As a follow-up to the Brief on the Confidentiality of Easement Agreement ("Brief"), Crowned Ridge Wind II, LLC ("CRW II") provides the following: (1) a refinement of the requested redactions in Intervenors August 6, 2019 Corrected Application for Party Status¹ ("Intervenors Application"); and (2) proposed language for a protective order.

On the first matter, after further review of Intervenors Application, CRW II is only seeking redaction of the full quote to Section 11.10 in the middle of page 4. CRW II requests that Section 11.10 be protected for the reasons set forth in the August 27, 2019
