Dear Ms. Van Gerpen:

Pursuant to Condition No. 41 (a)(b) and (c), Crowned Ridge Wind LLC (Crowned Ridge) submits its 30 day prior to construction compliance filings. Crowned Ridge plans to starts construction on August 29, 2019.

Based on the final sound report, Crowned Ridge notes that turbine CR-49 has been permanently dropped from the array to ensure compliance with the sound requirements under all construction of turbine scenarios.

Based on the final sound report, Crowned Ridge Wind, II LLC (Crowned Ridge II) will file a letter explaining that turbine CRII-126 has been removed to ensure compliance, and will only be used if receptor CR1-C11-NP, who is actually in the Crowned Ridge II footprint, becomes a participant. Crowned Ridge II will also shift turbine CRII-133 50 feet to the east to ensure Crowned Ridge is in compliance with sound requirements.

Turbine CR-Alt 22 was been shifted approximately 33 feet to the south for constructability purposes.

Last, turbine CR-16 is a Hessler alternate turbine. In the event this alternate turbine location is allowed as a primary turbine location consistent with Condition No. 27, turbine CR-16 will be curtailed for 13 hours on an annual basis to ensure shadow flicker is below the 30 hr/year threshold at receptor CR1-C61-NP
