- 5 A. I have a Bachelor of Science degree from the University of Northern Colorado.

- 7 A. For 22 years I has employed in the telecommunications industry performing project
- 8 management and land acquisition, through leasing and easements. I have been employed since
- 9 Aug 2016 with Engie, performing duties as a land agent securing easements and land acquisition
- 10 ``on large scale wind projects.

- 16 Q. What is the purpose of your direct testimony?
- 17 A. My purpose is to discuss landowner relationships within the project.

- 19 A. Yes.

### 20 Q. Can you describe your efforts?

- 21 A. As a land agent, I meet with land owners within the project area, and give them information
- regarding the project and the agreement that we want to sign placing their land under easement
- 23 for the purposes of wind development. I remain a liaison to the land owners in the project

24	through	out the	life of	the	project.

25	Q.	How many landowners are in the project area?			
26	A.	Currently there are 69,889 acres signed under easement, representing 151 parcels, with			
27	some landowners owning multiple parcels. There are approximately 100 landowners				
28	participating with their land under easement.				
29	Q.	Do they all have the same agreement?			
30	A.	Yes			
31	Q.	How long has this project been under development?			
32	A.	Since 2015			
33	Q.	Can you detail your efforts for the commission?			
34	A.	As a land agent, I am the main point of contact between the land owners and the project			
35	developers. I provide information regarding the details of the project, the progress of the wind				
36	development efforts, explaining the details of the Easement for Wind Energy Development that				
37	is presented to all landowners in the project area. My goal is to have a sufficient number of land				
38	owners enter into the easement agreement in order to successfully develop the wind project.				
39	Q.	Have you worked with the Commissioner of School and Public Lands to lease from			
40	that office?				
41	A.	Yes, since 2017 I have been in contact with Ryan Brunner, Commissioner of School and			
42	Public Lands for the State of South Dakota, discussing the state entering into the easement				
43	agreement and participating in the wind project. Mr. Brunner informed me that he signed the				
44	agreement on Jan. 31. Once it is received in our offices, we will route the document for counter				
45	signature.
