Dear Ms. Van Gerpen:

Northern States Power Company, doing business as Xcel Energy (NSP or the Company), submits this filing to the South Dakota Public Utilities Commission regarding the Wind Energy facility located in Deuel, Codington, and Grant Counties in South Dakota known as the Crowned Ridge II Wind Energy Facility (Crowned Ridge II).

The Commission's April 2, 2020 Site Permit – Permit Condition 8(e) states:

- 8. In accordance with applicable road use agreements or applicable law, Applicant shall comply with the following conditions regarding road protection
 - e) Within 180 days of completing construction and reclamation of the Project, Applicant shall submit documentation to the Commission identifying that the roads were repaired in accordance with Condition 8 and to the satisfaction of affected townships and counties. If a township or county will not provide such documentation, then Applicant shall provide a report to the Commission on the outstanding road repair issues and how those issues have been or will be resolved.

Construction of Crowned Ridge II was completed and commercial operation began on December 17, 2020. Crews continued with restoration and reclamation activities throughout the site, including completing local road repairs, which were fully completed on September 29, 2023. The table below shows the status of each road use agreement (RUA) for Crowned Ridge II.
