3. The claim for protection is based on ARSD § 20:10:01:39 (4) and SDCL § 37-29-1 (4). The information contained within the confidential portions of this report meets the definition of "trade secret" under the SDCL § 37-29-1(4), the South Dakota Uniform Trade Secret Act, which defines the term as information that "[d]erives independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use; and is the subject of efforts that are reasonable under the circumstances to maintain its secrecy."

The confidential portions tracker contains proprietary business information, specifically the live spreadsheet formulas which produce or derive the results stated therein (but not the results themselves), are confidential and proprietary to Otter Tail Power Company. The live spreadsheet formulas reflect components used to derive an agreed upon Rate of Return, which Otter Tail does not disclose to the public. Accordingly, Otter Tail respectfully requests that the Commission authorize confidential protection and treatment of this information.
