Pursuant to its Formula Rate Protocols,<sup>1</sup> NorthWestern Energy Public Service Corporation d/b/a NorthWestern Energy ("NorthWestern") submits this Informational Filing for its South Dakota Formula Rate Annual Update for the rate year that began April 1, 2024.

This submission is provided to the Commission for informational purposes only. This submission is not intended to be subject to the Commission's notice requirements, and the Commission need not take any action in response to this informational filing.

## I. Background

NorthWestern, which is a wholly-owned subsidiary of NorthWestern Energy Group, Inc., is a public utility engaged in the generation, transmission, and distribution of electricity located primarily in the state of South Dakota. NorthWestern is a transmission-owning member of SPP and SPP functionally controls NorthWestern's transmission facilities in South Dakota.
