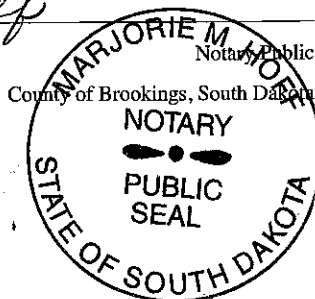

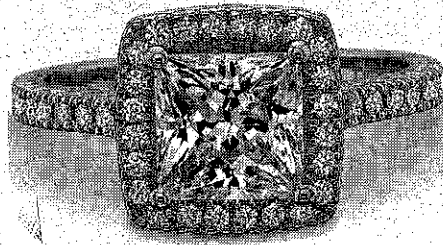
H & I Grain is no longer licensed or authorized to purchase grain at their Hetland, De Smet, Arlington or any other site within the state of South Dakota.
