The approximate 100,000 bushels of grain that I sold in July and August 2016 was on a cash sale. H&I would pick up the grain from my farm located approximately six miles from Hetland, SD, and would deliver it back to their facilities, and then issue a check to me every week. Since they did the hauling of the grain and ultimately were in charge of all grain tickets, I can only assume the records they have still showing I was owed for 3,725.35 bushels is correct.
