Thanks for taking the time to email your personal thoughts on the Keystone XL project to me and my colleagues Commissioners Kolbeck and Hanson.

You ask for us to conduct a thorough evaluation of this project, and I can assure you we have for all areas under the Commission jurisdiction. Since 2007 the Commission has reviewed thousands and thousands of pages of information and heard testimony from more than two dozen witnesses on the siting of interstate hydrocarbon pipelines. On the Keystone XL pipeline specifically, five Commission staffers, three Commissioners, and a number of outside expert consultants have spent months reviewing the project. Our environmental review has been conducted independently from any EIS and is not dependent upon the completion of an EIS. Our process reviewed hydrology, wildlife, plants and vegetation, erosion, soil types, noise, and many other areas of concern.

Have you taken an opportunity to review the Commission's order on the Keystone I pipeline

)? I do not know if the Commission's
decision on Keystone XL will be similar, but reading the
Keystone I order will provide you some context for the due
diligence that is conducted for projects of this type, and

reading the Keystone I order is well worth the time.
