1	<u>Allowance for Funds Used During Construction</u>
2	
3	Interest is computed on each construction job on which the construction period exceeds thirty days. No
4	allowance is computed on additions to land and land rights, and blanket projects. Interest is computed
5	on the cumulative balance plus one half of the current month's charges. Capitalization ceases when the
6	project is placed in service. The allowance rate is based on the composite cost of capital as required
7	under Federal Energy Regulatory Commission Order 561.
8	
9	<u>Injuries and Damages</u>
10	
11	Injuries and Damages provision is an amount deemed necessary for potential liabilities. The amount
12	capitalized is a percentage of straight time labor charged to capital. The provision is reviewed quarterly
13	and changed as required.
14	
15	<u>General and Administrative</u>
16	
17	General administration and engineering and supervision not directly assigned to specific jobs are
18	combined and recorded as an overhead cost. It is allocated on direct construction costs per project
19	monthly.
20	
21	<u>Labor Related Loadings</u>
22	
23	Payroll taxes and employee benefit expenses are charged to construction based upon a percentage of
24	straight time construction labor.
25	
26	<u>Corporate Facility Loadings</u>
27	
28	Costs associated with the four corporate buildings are charged to construction based upon the direct
29	labor charged by the employees in those facilities.

35	With the exception of the Corporate facility loading these methods and procedures have been in place
36	for the last five calendar years. The corporate facilities loading was implemented January 2012.
