## APPLICATION FOR PARTY STATUS

("Montana-Dakota Utilities Co.") by and through its attorneys and petitions the Commission for party status in accordance with SDCL 1-26-17.1 and Administrative Rules of South Dakota

(ARSD) 20:10:01:15:02 and 20:10:01:15.03, in the above captioned proceeding.

In support of its Petition, Montana-Dakota Utilities Co. states as follows:

- 1. The Commission has opened a docket to consider making a declaratory ruling regarding farm taps and the regulation thereof.
- 2. Montana-Dakota Utilities Co. owns and operates farm taps in South Dakota, and thus has a direct and substantial interest in the proceedings because the Commission's decision may affect the administration of Montana-Dakota Utilities Co. assets in South Dakota.
- 3. The interests of Montana-Dakota Utilities Co. are unique and cannot be fully and adequately represented by the existing parties.
