On March 16, 2023, the South Dakota Public Utilities Commission (Commission) received a filing from NorthWestern Corporation dba NorthWestern Energy (NorthWestern) for approval of a contract with deviations with POET Biorefining – Groton, LLC (Customer). The original contract with this Customer expired in 2018. At that time, a five-year renewal agreement was approved for service at a deviated rate through April 30, 2023. The Customer has reached the expiration of the five-year extension and NorthWestern desires to provide this customer with continuing natural gas service and has negotiated a new contract with deviations. This new rate will allow NorthWestern to maintain this Customer and will benefit NorthWestern and its natural gas customers through recovery of administration and general costs and common costs from this Customer. NorthWestern requests and effective date of May 1, 2023.

On March 23, 2023, the Commission electronically transmitted notice of the filing and the intervention deadline of April 11, 2023, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were filed.

The Commission has jurisdiction in this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-3, 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-83, 49-34A-10, and 49-34A-11.

At its regular meeting on April 13, 2023, the Commission considered this matter. Commission staff recommended approval. Finding that NorthWestern's request for approval of a contract with deviations with Customer and the associated tariff sheet is just and reasonable, the Commission voted unanimously to grant NorthWestern's request for approval of a contract with deviations and to approve the associated tariff sheet with an effective date of May 1, 2023. It is therefore

ORDERED, that NorthWestern's request seeking approval of a contract with deviations with Customer is hereby granted with an effective date of May 1, 2023. It is further

ORDERED, that the revisions of the above-referenced tariff sheet to reflect the contract with deviations with Customer are hereby approved, effective May 1, 2023.
