**MOTION REQUESTING MODIFICATION OF COMMISSION’S ORDER  
DESIGNATING WWC LICENSE LLC, AS AN ELIGIBLE  
TELECOMMUNICATIONS CARRIER**

COMES NOW, WWC License LLC, a wholly-owned subsidiary of Alltel Communications, Inc., by and through its attorney of record, Talbot J. Wiczorek of the law firm of Gunderson, Palmer, Goodsell & Nelson, LLP, hereby moves this Commission for an Order Amending the Commission’s Order designating WWC License LLC an Eligible Telecommunications Carrier (“ETC”). This motion is based on the following reasons:

1. That on January 3, 2005, this Commission, after full hearings and briefings on the matter, designated WWC License LLC as an ETC within additional areas in South Dakota. This designation was made subject to various conditions contained in nine sub paragraphs found within that Order at the end of the findings of fact on pages seven to nine of the Order.
2. Some of the conditions require that WWC License LLC report certain information annually to the South Dakota Commission. Specifically, conditions numbers 8 and 9 require the Company to provide annual reports by January 1 of each year or at another time agreed to with staff. Subsequent to the date set in that Order, WWC License LLC and Staff discussed changing the date of compliance by April 1 of each year. The type of information requested includes submission of proposed construction plans and new facilities and service enhancements detailing any customer complaints and detailing unfulfilled service requests.
3. Other conditions required annual reporting but did not set a reporting date. Historically, WWC License LLC has been providing these reports by the April 1 time frame.

These filings have included such information as documentation of satisfying statutory objectives to offering services. See Condition number 3.


4. Subsequent to the entry of the Order Designating WWC License LLC as an ETC, the Commission has extensively amended its annual ETC certification filings. These annual certification filings now require ETCs to report by June 1 much of the same information that WWC was required to file by April 1 of each year. This includes such details as proposed plans for service improvements, information on customer complaints and unfulfilled service requests. See A.R.S.D. 20:10:32:54.

5. As a result, WWC License LLC, under its current obligations would have to report information by April 1 and then update the information and file again by the June 1 deadline. To avoid the need to create two reports, WWC License LLC desires to have all annual reports coincide with the June 1 deadline for annual certification.

WHEREFORE, WWC LICENSE LLC, respectfully request the Commission enter an Order Amending its Order Designating WWC License LLC an ETC and setting forth that any annual reports required to be filed under that Order be changed to June 1 of each year so that the filing coincide with the annual certification filing.


