dog control. On larger towns (Aluminum Phosphide) tablets will run 5-10x the cost per acre versus baiting. Yearly checks of dog towns and monitoring the populations even after a baiting program will help keep numbers in check.

Coyotes are also whelping pups and setting up dens by now and becoming territorial that makes calling and using coyote vocalizations a big tool at this time of year. The calling has been getting better with each passing week and by month's end, it will be a tool I rely on to remove problem coyotes. The use of a dog with calling works really well. Now till the end of August will be a time were they put most of their efforts into raising those pups. I will be calling a lot and trapping coyotes, as these tools work well during the summer. If you have any problems be sure and give me a call! We have had the plane up some this spring and took 42 coyotes in the areas they were causing problems, the weather has not been good for aerial hunting, but the plane is a needed part of predator control.

## Extension Trapper News

We're half way through the month of May and the cool/wet weather we have had has been a good thing for grass growth. I hope all had successful calving and hope the spring lambing is going well for all the sheep producers.

This month I would like to start out with some biological information on prairie dogs. The prairie dogs have had their litter of pups by now, they breed from January to March and have a gestation of 34 days with 1-6 pups being born. They stay down in the den for 6

weeks before emerging and the females spend a lot of time with the young. Come fall they will be almost full grown.

Control of the prairie dogs is time dependant and weather dependant. This year with the nice rains we have had, cool temperatures which are good for grass growth, and the prairie dogs will depend on this for a big part of their diet. The Bait we use in South Dakota is Zinc Phosphide and is the only bait labeled for prairie dogs and works really well, if applied at the proper time and

### **National Do Not Call Registry**

The National Do Not Call Registry has been established to offer you a choice about receiving telemarketing calls at home. Registering will stop most telemarketing calls but it will not stop calls from political organizations, charities, companies conducting surveys, or companies with whom you have done business in the last 18 months.

Consumers can register their residential phone numbers, including wireless numbers, but businesses numbers are not covered by the Registry. The number will be on the Do Not Call list the day after registration; however, telemarketers have up to 31 days to remove the number from their call lists. Registration is effective for five years and a number can be removed from the list at any time. You may register up to three numbers at one time if registering on the Internet. If registering via telephone, you can register only one number at a time and you must call from the telephone number you are registering.

## BILLING NAME & ADDRESS DISCLOSURE

When you place a calling card call, or accept a collect call or third-number billed call, your telephone company is required to provide your billing name and address to the telecommunications service provider that handled the call, if that provider requests. Your telephone company will continue to provide billing name and address information to telecommunications service providers for other account matters, such as customer service, servicing your account, to prevent fraud or when you move from one location to another.

## LOW INCOME ASSISTANCE AVAILABLE

Faith Municipal Telephone Company is authorized to provide two federal telephone assistance programs that were developed in response to concerns about the affordability of telephone service for low income citizens.

The Lifeline program provides reduced monthly charges to telephone subscribers who qualify.

The Link Up program provides reduced connection charges to telephone subscribers who qualify.

### WHO IS ELIGIBLE?

Subscribers must participate in at least one of the following public assistance programs to be eligible:

Medicaid, Food Stamps, Low Income Home Energy Assistance Program, Supplemental Security Income (SSI), or Federal Housing Assistance

### WHAT DO THE PROGRAMS PROVIDE?

Lifeline provides eligible subscribers with a credit of \$6.50 each month on the basic service portion of the telephone bill. The credit applies on the main home telephone line listed in the name of the eligible telephone company subscriber. Lifeline subscribers also may receive blocking of long distance calling on their telephone line at no charge.

Link Up provides eligible subscribers with reduced connection charges for their basic home telephone service. This reduction is 50 % of applicable charges or \$30.00, whichever is less. Link Up also provides for deferred payment of connection charges without interest. It does not cover the cost of wiring inside the home and is limited to one time per home address per subscriber.

### HOW DO I APPLY?

If you meet the eligibility requirements, you must completely fill out and sign an application form. Application forms are available at our office at: Faith Municipal Telephone Company, PO Box 368, Faith, SD, 57626.

### COULD I BECOME INELIGIBLE?

When you no longer are eligible to participate in any of the above assistance programs, you are no longer eligible for Lifeline or Link Up. You are obligated by law to notify Faith Municipal Telephone Company and advise the company that you are no longer eligible for Lifeline and Link Up.

## PAY-PER-CALL BILLING RIGHTS

Some companies offer a variety of informational services using phone numbers beginning with 900. There is usually a charge for calls to these numbers. The price and content of these services are established by the companies providing the information.

For 900 billing disputes or inquiries, please call your local telephone company. You have 60 days from the date of the bill to dispute a 900 billing error review. You have the right to withhold payment of the disputed 900 charges during the billing error review. No collection activity for disputed 900 charges will occur while the charges are under investigation. After investigation, if it is determined that the disputed 900 charges are legitimate, the long distance company or the information provider may proceed with outside collections against your account for nonpayment of these charges. Your local and long distance service cannot be disconnected for nonpayment of 900 charges. Failure to pay legitimate 900 charges may result in involuntary blocking of access to 900 services. Voluntary blocking of access to 900 services is available upon request from your local telephone company.

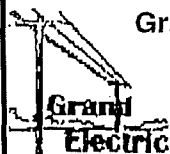

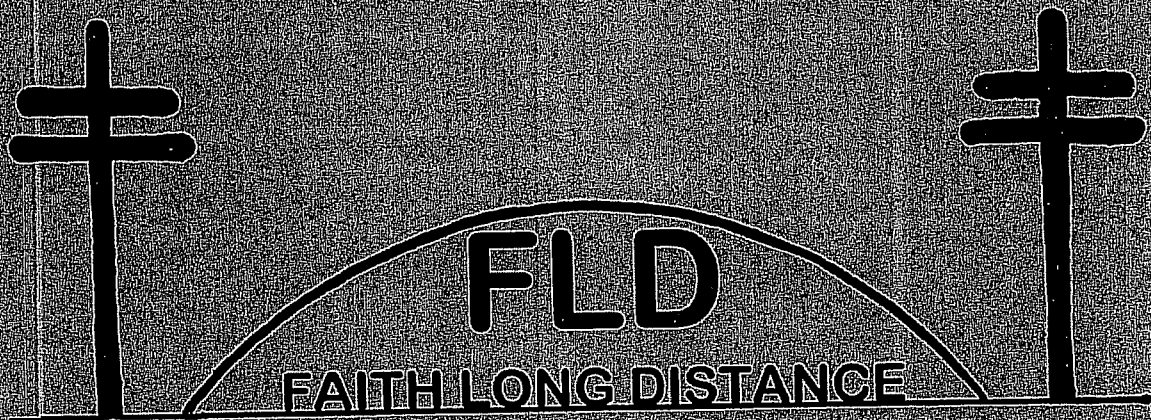
