APPLICATION FOR AMENDED CERTIFICATE OF AUTHORITY

The South Dakota Public Utilities Commission ("Commission") issued a Certificate of Authority to Minnesota Independent Interexchange Corporation d/b/a Polaris Telecom ("MIIC") on July 31, 1992, in Docket No. TC92-071 ("Docket TC92-071"), to provide interexchange toll service to customers of Farmers Mutual Telephone Company and Valley Telephone Company.

Onvoy, Inc. ("Onvoy") requests that its current Certificate of Authority be amended to permit Onvoy to provide interexchange toll service in all areas of South Dakota. In support of its Application, Onvoy states as follows:

- 2. Services will be provided under the name of Onvoy, Inc.
- 3. (a) Onvoy is a Minnesota corporation formed on October 6, 1988. Onvoy is the parent company of a wholly owned subsidiary, Minnesota Independent Equal Access Corporation (MIEAC), a Minnesota corporation founded on December 8, 1988. A dia-

gram depicting the organizational structure of Onvoy and its subsidiary is attached as Exhibit A. MIIC was merged into Onvoy on July 21, 2000. Copies of Onvoy's registration as a Foreign Corporation with the South Dakota Secretary of State and its Certificates of Incorporation issued by the Minnesota Secretary of State are attached as Exhibit B.

- (b) Onvoy's headquarters is located at 300 South Highway 169, Suite 700, Minneapolis, MN 55426. Onvoy's web page is www.onvoy.com and its main telephone number is (952) 230-4100. Onvoy's registered agent in South Dakota is CT Corporation System, Inc. CT Corporation System, Inc. has an office at 319 South Coteau St., Pierre, South Dakota 57501.
- (c) Onvoy has one major private investor that owns more then a 20 percent managing interest in Onvoy. This individual company is Quantum Industrial Partners, LDC and its offices are located at 888 7th Avenue, 32nd Floor, New York City, NY 10106. Quantum Industrial Partners has a 39% ownership in Onvoy.
- 4. Onvoy seeks authority as an IXC for the entire state so that it can provide 1+ Intrastate toll calling, toll free service and operator services. Onvoy will employ a combination of its own equipment, and services and facilities from other carriers to provide the 1+intrastate long distance services. Onvoy will be selling long distances services to businesses and wholesale markets.
- 5. Onvoy is a regional telecommunications and internet services provider that operates Minnesota's largest privately-owned fiber network. This fiber network delivers wholesale and retail telecommunications services to Minnesota independent telephone companies, global interexchange carriers, enterprise clients and the State of Minnesota. As of the end of March 2005, Onvoy provided long distance to 130,900 access lines in Minnesota. Onvoy's centralized equal access service provides a choice of 1+ long dis-

tance service to 295,000 total access lines from 78 telephone companies. Onvoy's network spans 3,500 miles throughout Minnesota and it serves approximately 12,000 private lines ranging from DS1 to OCn capacity.

Onvoy clearly meets all the technical, managerial, financial and legal qualifications required of applicants for certification from the Commission. Onvoy's management personnel have, in the aggregate, over 67 years of experience in the ownership and operations of telecommunications companies. Onvoy's management group is currently responsible for successful facilities based CLEC, IXC, wholesale telecommunications, and centralized equal access services in Minnesota and other Midwestern states as show in the table in Section 9.

- 6. Onvoy will be offering 1+ intrastate toll calling, toll-free service and operator services throughout the entire state.
- 7. Onvoy has the financial resources to operate its current facilities and services as demonstrated by Exhibit C to this application and to provide services in South Dakota. Exhibit C contains abbreviated financial statements for Onvoy, a privately held company. Onvoy considers its annual report trade secret information.
- 8. Potential customers can call Onvoy's toll free number 1-877-336-6869 for general questions or billing inquiries. Customers can report technical problems via a toll free number or on line at Onvoy's web page: www.onvoy.com. The e-mail addresses for billing and sales are: billing@onvoy.com and sales@onvoy.com. 9. Onvoy and its subsidiary hold a Certificate of Authority in a number of Midwestern states, as follows:

- 10. As outlined in section 4, Onvoy plans to sell its long distance services to business and wholesale markets. Onvoy plans to market its services via sales contacts, referrals and its web site.
- 11. The services will be provided to Onvoy's customers under the terms of Onvoy's Tariff currently on file with the Commission.
 - 12. Onvoy's Federal Tax Identification number is 41-1624131.
- 13. Onvoy has not had any reported complaints from applicants or customers concerning the unauthorized switching of a customer's long distance provider in the last two years.

14. Therefore, Onvoy respectfully requests that its Certificate of authority issued in TC92-071 be amended to permit Onvoy to provide interexchange services in all exchanges of South Dakota.

Onvoy Organizational Structure






