SOUTH DAKOTA PUBLIC UTILITIES COMMISSION 4. The parties move that SSTelecom be granted authority to utilize the switched access rates identified in SSTelecom's switched access services tariff attached to the Stipulation for the time periods identified therein.

5. This Stipulation resolves the issues in Docket TC05-223 relating to company specific cost based switched access rates.

6. The Stipulation represents a negotiated settlement of specific issues in this case. The terms of the Stipulation agreed upon are, to the belief of the Parties, just, fair, and reasonable and consistent with South Dakota law. The parties respectfully request the Commission approve the Stipulation.

For the foregoing reasons, the undersigned parties jointly request that the Commission adopt the attached Stipulation for the purpose of resolving the specific issues for use in setting the intrastate switched access rates of SSTelecom, Inc. in docket TC05-223. Should the Commission fail to adopt the attached Stipulation, or modify the same, the parties shall, at their discretion, proceed with Docket TC05-223 as though no stipulation had been presented to this Commission.
