for Delay of Hearings on MCC Telephony of the Midwest, Inc.'s  
Application for Authority to  
Provide Local Exchange Services in Certain Rural Areas**

MCC Telephony of the Midwest, Inc. d/b/a Mediacom ("MCC"), Brookings Municipal Utilities d/b/a Swiftel Communications ("Swiftel"), South Dakota Telecommunications Association ("SDTA") and Interstate Telecommunications Cooperative, Inc. ("ITC") (collectively referred to as the "Parties") agree that the hearings in the above-captioned matters should be postponed by this Commission.

The Parties agree that all deadlines for filing prehearing materials should be continued. The Parties agree that all discovery shall be served by January 21, 2008. The Parties agree the due date for all discovery shall be February 21, 2008. The Parties further agree that they shall thereafter cooperate in the scheduling of the remaining prehearing deadlines for the following: motions to compel; prefiled direct testimony; prefiled response testimony; and designation of additional witnesses for rebuttal and exchange of additional exhibits for use by rebuttal witnesses. The Parties further agree that the post hearing deadlines should be rescheduled after

the Commission has rescheduled the hearings based on availability of the Commission, the Parties and their respective witnesses.

To the extent that the Commission may face a statutory timeline in rendering a decision or granting a certificate of authority, the Parties hereby agree to waive the timeline and stipulate that the Commission shall meet the said timeline as long as a final decision is rendered by July 31, 2008.


