Commission Staff, by and through its attorney, Kara Van Bockern, respectfully requests the Public Utilities Commission of the State of South Dakota to continue the Procedural Order as it relates to Discovery. Specifically, Commission Staff requests the April 13, 2007 deadline for Staff's follow-up discovery to be extended thirty days to May 13, 2007. Commission Staff also offers EchoStar, and any other entity joined in this proceeding, an opportunity to request follow-up discovery until June 13, 2007.

In addition, Commission Staff respectfully requests that the Public Utilities Commission add the following parties to the caption in TC06-191: EchoStar Communications Corporation, EchoStar Orbital Corporation, II, EchoStar DBS Corporation, EchoStar International Corporation, EchoStar LLC, Dish Network Service LLC, Dish Network California Service Corporation, and EchoStar Technologies. Such entities were discovered only after receipt of EchoStar Satellite LLC's discovery responses. It appears all entities are intricately tied to digital TV services marketed in South Dakota as Dish Network.

Attached hereto and incorporated by reference is a Brief in support of this Motion. Movant respectfully requests the Commission consider the brief, and then enter an order extending discovery dates and to add additional parties to the docket.
