**PETITION** 

West River Cooperative Telephone Company ("West River") by and through its Attorney, Darla Pollman Rogers of Riter, Rogers, Wattier & Brown, LLP, respectfully requests that the South Dakota Public Utilities Commission ("Commission") grant it an extension of the deadline for filing its 2006 cost study, as follows:

- 1. ARSD § 20:10:27:07 requires a carrier's carrier to file cost data in support of its switched access service tariff no less than once every three years.
- 2. ARSD § 20:10:27:14 requires carriers to file a cost study within six (6) months of the close of the test year upon which the carrier is relying to support a change in switched access rates. The rule also gives authority to the Commission to grant an extension of the six (6) month filing period, upon request of the carrier.
- 3. West River filed a cost study on or about June 30, 2003 (Docket TC03-106). Pursuant to ARSD § 20:10:27:07 and ARSD § 20:10:27:14, West River is required to file a cost study no later than June 30, 2006.
- 4. West River requests an extension of the six (6) month filing period, for the following reasons:

- a. West River anticipates there will be a change in the intrastate switched access rules in the near future, either through new intercarrier compensation rules adopted by the FCC, or pursuant to the rule-making docket currently pending before this Commission. West River requests an extension of the six (6) month filing deadline for submitting its 2006 cost study until such time as there is a clear indication of what will be required of carriers under the new switched access regime.
- b. West River is a member of the Local Exchange Carriers Association ("LECA"). LECA is currently negotiating with Commission Staff and Intervenors in the 2005 cost study dockets for settlement of the 2005 cost study dockets, pending the events in subparagraph (a) above. Said settlement may include an agreement by individual carriers such as West River to not file a cost study in 2006. West River requests this extension to allow the settlement negotiations to continue and in order to study the effects of a settlement, if one is reached, upon West River.
- c. West River will retain its current access rates, pending the outcome of the events in subparagraph (a) & (b) above, or until West River files a 2006 cost study, pursuant to the granting of its request herein to extend the filing deadline.

WHEREFORE, West River respectfully requests the Commission to grant West River an extension of the six (6) month filing deadline for filing its 2006 cost study.
