COOPERATIVE'S AREAS**


MCC Telephony of the Midwest, Inc., d/b/a Mediacom, through its attorney Brett Koenecke of May, Adam, Gerdes & Thompson, hereby moves to withdraw its Application for Authority to Provide Local Exchange Service in certain Interstate Telecommunications Cooperative, Inc. (the Application) areas in the above-captioned docket, without prejudice.

At this time, MCC has determined it will not pursue its intentions to provide local exchange service in the above-captioned ITC territories. Given that MCC will not be providing local exchange services, any services MCC currently or will be providing within these ITC areas do not require additional certifications from this Commission. MCC reserves the right to seek certification to provide local exchange services in ITC areas in the future.

Therefore, MCC respectfully requests that the Commission grant its Motion to Withdraw the Application. MCC also asks the Commission to delay all scheduled filing in the docket to allow the Commission to take action on this Motion, as necessary.


