JOINT APPLICATION

STi Prepaid, LLC ("STi Prepaid") and Dialaround Enterprises Inc. ("DEI") (the "Applicants"), through their undersigned counsel and pursuant to SDCL 49-31-3 and ARSD 20:10:24:04.01 and 20:10:24:02, hereby request approval from the South Dakota Public Utilities Commission ("Commission") to transfer DEI's assets, including DEI's authority to provide intrastate resold interexchange telecommunications services in South Dakota, to STi Prepaid. STi Prepaid also requests authority to provide prepaid calling card service in South Dakota. To facilitate the asset transfer, STi Prepaid also provides the information necessary under the South Dakota Administrative Rules to demonstrate that it is qualified to hold DEI's certificate of authority to provide resold interexchange telecommunications services that DEI currently provides in South Dakota, as well as prepaid calling card service.

I. DESCRIPTION OF THE TRANSACTION

On January 23, 2007, DEI and certain of its affiliates (collectively, "Sellers") entered into an Asset Purchase and Contribution Agreement ("Agreement") with STi Prepaid and certain of its affiliates pursuant to which Sellers agreed to transfer all or substantially all of their assets and liabilities to STi Prepaid, including DEI's authorizations to provide telecommunications services (the "Transaction"). Consummation of the Transaction is contingent on, among other things, receipt of all necessary regulatory approvals.

Pursuant to the terms of the Agreement, STi Prepaid will purchase seventy-five percent (75%) of the assets and assume seventy-five percent (75%) of the Sellers' liabilities. The assets to be transferred by the Sellers to STi Prepaid include DEI's authorizations to provide telecommunications services. At the completion of the Transaction, STi Prepaid will hold DEI's authorizations to provide telecommunications services.

ST Finance, a Delaware limited liability company whose principal business is securities holdings, will own the remaining twenty-five percent (25%) interest in STi Prepaid after consummation of the Transaction. Samer Tawfik, a United States citizen, will indirectly own a one hundred percent (100%) membership interest in ST Finance through seven holding companies, all of which are Delaware entities. The seven holding companies are: Telco Group, Inc., STi Phonecard Inc., Dialaround Enterprises Inc., STi Mobile Inc., Phonecard Enterprises Inc., VOIP Enterprises Inc., and STi PCS, LLC. Thus, Samer Tawfik will hold a twenty-five percent (25%) indirect interest in STi Prepaid after consummation of the proposed Transaction.

II. DESCRIPTION OF THE APPLICANTS

A. STi Prepaid, LLC

STi Prepaid, a Delaware limited liability company, is an indirect subsidiary of Leucadia National Corporation ("Leucadia"), a publicly traded New York corporation with headquarters at 315 Park Avenue South, New York, NY 10010. STi Prepaid is a newly-formed entity that will hold DEI's authorizations to provide telecommunications services after consummation of the Transaction. In conjunction with the Transaction, STi Prepaid therefore requests authority to provide intrastate resold interexchange telecommunications services in South Dakota, including dial-around and prepaid calling card services.

B. Dialaround Enterprises Inc.

DEI is a privately held Delaware corporation with headquarters at 30-50 Whitestone Expressway, 4th Floor, Flushing, New York 11354. Samer Tawfik, a United States citizen, is DEI's sole owner. The Commission authorized DEI to "provide interexchange telecommunications services in South Dakota, subject to the condition that it not offer a prepaid calling card or require or accept deposits or advance payments without prior approval of the Commission." DEI currently provides dial-around services in South Dakota.

IV. THE TRANSACTION IS IN THE PUBLIC INTEREST

The proposed Transaction furthers the public interest, convenience, and necessity. The assignment of DEI's assets to STi Prepaid will benefit consumers by ensuring that they continue to have a wide range of telecommunications choices in the long distance market. As an affiliate

of Leucadia, a publicly traded company, STi Prepaid will have access to the public capital markets that can provide support for the expansion of the services that DEI currently offers. STi Prepaid will benefit from DEI's experience providing telecommunications services, which will be further enhanced by STi Prepaid's access to the telecommunications expertise of Leucadia, which previously has managed numerous other providers of telecommunications services through various subsidiaries. The combination of DEI's existing technical experience and Leucadia's financial backing will enhance STi Prepaid's ability to efficiently provide and expand its services.

The proposed Transaction does not present any anticompetitive issues. Consumers utilizing DEI's dial-around services will continue to receive high-quality telecommunications services without interruption and without change in rates, terms, or conditions. DEI currently provides resold interexchange telecommunications services in South Dakota pursuant to DEI's tariff, Dialaround Enterprises Inc. South Dakota P.U.C. Tariff No. 1 issued April 29, 2003. Immediately following consummation of the Transaction, STi Prepaid has provided a proposed tariff with this application that proposes to offer consumers the same services at the same rates, terms, and conditions as were previously offered by DEI. Accordingly, the contemplated Transaction will be virtually transparent to consumers.

Customer notice is not required in this case because DEI does not have a dedicated customer base. DEI's services can be used by any person at any time by dialing a specified access code prior to making a telephone call. DEI has no knowledge of the identity of the persons that utilize its dial-around services, and has no relationship with the person utilizing the dial-around code (a third-party billing and collection vendor interacts with the customer after the

dial-around service is used). Accordingly, customer notification of this Transaction is unnecessary and would be almost impossible.

V. STI PREPAID IS QUALIFIED TO PROVIDE SERVICE IN SOUTH DAKOTA

A. STi Prepaid Has the Necessary Managerial, Technical, and Financial Qualifications

STi Prepaid is well qualified to provide telecommunications services in South Dakota.

STi Prepaid will utilize a significant number of the same employees and the same assets that DEI currently uses to provide telecommunications services in South Dakota, and will therefore be well positioned to provide the same quality services that DEI currently provides. The biographies of the persons responsible for the day-to-day operations of STi Prepaid (found in Exhibit B) demonstrate STi Prepaid's managerial and technical qualifications to provide telecommunications service. In addition, STi Prepaid and its ultimate corporate parent Leucadia have the financial qualifications to provide telecommunications services in South Dakota as demonstrated by the financial statements provided in Exhibit C.

BEI Prepaid, LLC. BEI Prepaid, LLC ("BEI Prepaid"), a Delaware limited liability company will own a seventy-five percent (75%) interest in STi Prepaid after consummation of the Transaction. BEI Prepaid's principal business is telecommunications holdings. David Larsen, a United States citizen, holds a ten percent (10%) non-voting membership interest in BEI Prepaid. BEI Prepaid Holdings, LLC, a Delaware limited liability company whose principal business is telecommunications holdings, owns a ninety percent (90%) membership interest and a one hundred percent (100%) voting interest in BEI Prepaid. BEI Prepaid Holdings, LLC is a wholly owned subsidiary of Baldwin Enterprises Inc. ("Baldwin"), a Colorado corporation whose principal business is investment. Baldwin is a wholly owned subsidiary of Phlcorp, Inc., a Pennsylvania corporation whose principal business is investment holdings. Phlcorp, Inc. is a wholly owned

subsidiary of Leucadia, a publicly traded New York corporation whose principal business is investment. Ian Cumming and Joseph Steinberg, both of which are United States citizens, each hold a thirteen percent (13%) interest in Leucadia. - 5) Description of the telecommunications services the applicant intends to offer: As noted above, STi Prepaid plans to provide resold interexchange telecommunications services in South Dakota, including dial-around and prepaid calling card services.

- 6) The means by which the Applicant will provide its services: The Applicant plans to offer resold interexchange telecommunications services utilizing the services of other carriers certificated in South Dakota.
- 7) Applicant's proposed geographic serving and calling areas: STi Prepaid plans to provide resold interexchange service throughout the entire State of South Dakota.
- 8) Applicant's current financial statements, including balance sheet, income statement, and cash flow statement, annual report, report to stockholders: Leucadia, the ultimate majority owner of STi Prepaid, satisfies the necessary financial requirements as demonstrated by its financial statements attached as Exhibit C.

prepaid calling card services do not receive a bill from STi Prepaid. Customer service matters are handled by Patricia Newbold as discussed in the response to question 12 above.

- 10) List of states in which the applicant is registered or certified to provide telecommunications services: STi Prepaid is in the process of obtaining the necessary authorizations to provide interexchange services in all fifty states. STi Prepaid has never been denied registration or certification in any state, and it is in good standing in the states where it is registered or certified.
- 11) Description of how the applicant intends to market its services, its target market, multi-level marketing, if any, and copies of any company brochures: STi Prepaid intends to use point-of-sale displays and the Internet for marketing of its prepaid calling card services.
- 12) Cost support for rates shown in the company's tariff for all noncompetitive or emerging competitive services: Not applicable.

- 14) Slamming and cramming complaints: No slamming or cramming complaints have been filed against STi Prepaid.
- 15) Waivers: STi Prepaid requests all waivers routinely granted by the Commission to entities seeking authority to provide resold interexchange telecommunications services, including prepaid calling card services.
- 16) Other information requested by the Commission: STi Prepaid will promptly respond to any Commission requests for additional information.

WHEREFORE, the Applicants respectfully request Commission approval of this Joint Application and the issuance of a certificate of authority for STi Prepaid to provide resold

interexchange telecommunications services, including dial-around and prepaid calling card services. Specifically, the Applicants respectfully request Commission approval to transfer DEI's assets, including DEI's authority to provide intrastate resold interexchange telecommunications services in South Dakota, to STi Prepaid, and thereafter cancel DEI's certificate of authority and tariff. STi Prepaid also requests additional authority to provide prepaid calling card service in South Dakota. Further, STi Prepaid requests Commission approval of its proposed tariff and the rates proposed therein.
