Comes now Knology of the Plains, Inc. and Knology of the Black Hills, LLC (together, Knology Entities) and moves the Commission to withdraw its intervention in TC07-107.

On October 5, 2007, the staff (Staff) of the South Dakota Public Utilities Commission (Commission) filed a Motion for Order to Show Cause (Motion) against Reduced Rate Long Distance, LLC (Reduced Rate). The Motion alleged that as early as 2005, the Commission's Consumer Affairs Division (Consumer Affairs) began receiving complaints regarding alleged misrepresentations by Reduced Rate that resulted in changes to subscribers' telecommunications service providers or added products or services to subscribers' bills without express authority from the subscribers in violation of SDCL 49-31-89 and ARSD 20:10:34:06. The Motion further alleges that to date, Consumers Affairs has collected 22 such complaints.

On December 27, 2007, the Commission received a Petition to Intervene from PrairieWave Black Hills, LLC and PrairieWave Telecommunications, Inc. (now known as the Knology entities). At its regular meeting on January 15, 2008, the Commission voted unanimously to grant intervention to Knology.

Prior to its intervention in this proceeding, Knology filed a separate complaint against Reduced Rate Long Distance, Docket No. TC07-105.

The Staff of the Commission and Reduced Rate have entered into a settlement of this Show Cause proceeding. Knology does not wish to be a signatory to the settlement agreement.

Wherefore the Knology Entities move that its granted intervention status in the aforementioned docket be withdrawn.


