

This letter memorializes our agreement regarding the date on which Alltel Communications, Inc. ("Alltel") received Kennebec Telephone Company's ("Kennebec") request for negotiations of an Interconnection Agreement pursuant to § 251(b) of the Communications Act of 1934, as amended (the "Act"). For purposes of the Act, Alltel and Kennebec agree that Alltel received Kennebec's request for negotiations on March 14, 2008. Based upon that date, the 135th day (the opening of the arbitration window) will fall on July 28, 2008, and the 160th day (closing of the arbitration window) will fall on August 22, 2008, with the Commission being required to act by December 14, 2008.
