### **JOINT APPLICATION**

Computer Network Technology Corporation (a/k/a McDATA Services Corporation) ("CNT") and Bandwidth.com CLEC, LLC ("Bandwidth") (CNT and Bandwidth collectively, "Applicants"), through their undersigned counsel and pursuant to Section 49-31-3 of the South Dakota Codified Laws and Sections 20:10:24:02 and 20:10:32:03 of the Administrative Rules of South Dakota, request South Dakota Public Utilities Commission ("Commission") approval or such other authority as may be necessary or required for Bandwidth to acquire the Certificate of Public Convenience and Necessity ("Certificate") of CNT. Specifically, Bandwidth.com, Inc. ("Buyer"), the parent of Bandwidth, and CNT have entered into an Asset Purchase Agreement ("Agreement") whereby Buyer has agreed to purchase substantially all of CNT's regulated telecommunications services operations ("Assets"), including CNT's South Dakota's Certificate. [1]

CNT does not provide intrastate telecommunications services or have any intrastate telecommunications facilities in South Dakota. As a result, Applicants have not provided a form of customer notice.

The Applicants request that the Commission act expeditiously to grant the authority requested herein as soon as possible so that the Applicants can timely consummate the proposed transaction in order to meet important business objectives.

In support of this Application, the Applicants state as follows:

# I. <u>DESCRIPTION OF THE APPLICANTS</u>

# A. Computer Network Technology Corporation ("CNT")

CNT is a corporation organized under the laws of the state of Minnesota, which operates under the names CNT and McDATA Services Corporation. CNT's business address is 6000 Nathan Lane North, Minneapolis, Minnesota 55442. CNT became a wholly owned indirect subsidiary of Brocade Communications Systems, Inc. ("Brocade") in February, 2007 upon completion of the acquisition of CNT's corporate parent, McData Corporation. CNT provides telecommunications services to Brocade's customers who purchase data networking solutions involving hardware, firmware, software, professional services, and data only connectivity and remote systems monitoring from Brocade or its affiliates. As stated in footnote 1, however, CNT does not provide any intrastate telecommunications services in South Dakota.

Brocade is a Delaware corporation with principal offices located at 1745 Technology Drive, San Jose, California 95110. Brocade is publicly traded on the NASDAQ Global Select Market under the symbol "BRCD." Brocade does not directly hold any authorizations relating to the provision of telecommunications services.

Brocade designs, develops, markets, sells, and supports data storage networking and application infrastructure management solutions, offering a line of storage networking products, software and services that enable companies to implement highly available, scalable,

manageable, and secure environments for data storage applications. Brocade products are installed around the world at companies, institutions, and other entities ranging from large enterprises to small and medium size businesses. Additional information regarding Brocade is available on the company's website at: http://www.brocade.com.

In South Dakota, CNT is authorized to provide local exchange and interexchange telecommunications services pursuant to a certificate granted in Docket No. TC03-202 on April 19, 2003. CNT is authorized to provide intrastate telecommunications services in approximately 42 other states and the District of Columbia. Its affiliate, CNT Telecom Services, Inc. is currently authorized to provide telecommunications services in two additional states: Alabama and Virginia. CNT is also authorized by the FCC to provide international and domestic interstate telecommunications services as a non-dominant carrier. In nearly all states where Bandwidth does not already have a Certificate and where permitted by law, the Certificates and authorizations of CNT will be transferred to Bandwidth.

#### B. Bandwidth.com CLEC, LLC ("Bandwidth")

Bandwidth is a Delaware limited liability company formed on January 9, 2007. Bandwidth is a subsidiary of Bandwidth.com, Inc., a Delaware S Corporation providing voice and data services. A copy of Bandwidth's incorporation documents are attached hereto as <a href="Exhibit A">Exhibit A</a>. Attached as <a href="Exhibit B">Exhibit B</a> is a copy of Bandwidth's Certificate of Authority to Transact Business as a foreign corporation in South Dakota.

Bandwidth is authorized to provide telecommunications services in the following states: California, Florida, Georgia, Illinois, Kentucky, Michigan, Montana, New York, New Hampshire, North Carolina, North Dakota, Ohio, Pennsylvania, Texas and Washington. Bandwidth is in the process of obtaining similar authority to provide telecommunications

services in all other states. Bandwidth is also authorized by the FCC to provide international and domestic interstate telecommunications services as a non-dominant carrier.

Bandwidth has the technical, managerial, and financial qualifications to acquire the Certificate of CNT. Bandwidth is operated by a highly qualified management team, all of whom have extensive backgrounds in information technology, networking and computer industries. Management biographies for the Bandwidth/Buyer management team are attached hereto as <a href="Exhibit C">Exhibit C</a>. Buyer's most recent financial statements are provided *under seal* as <a href="Exhibit D">Exhibit D</a>. Additional information regarding the qualifications of Bandwidth is provided in Section IV, below.

III. **DESCRIPTION OF THE TRANSACTION** 

Through the Agreement described above, CNT has agreed to sell to Bandwidth certain

assets of CNT, including certain of CNT's authorizations to provide intrastate services (the

"Transaction"). Following the proposed Transaction, CNT will not provide intrastate common

carrier services in South Dakota and Bandwidth will replace CNT as a Certificated entity in South

Dakota. Applicants, therefore, respectfully request that the Commission allow CNT to transfer its

existing South Dakota Certificate to Bandwidth (and change the name associated with the

Certificate to Bandwidth) with the same conditions as previously granted to CNT. In the event that

the Commission determines that the South Dakota Certificate granted to CNT cannot be transferred

to Bandwidth, Applicants respectfully request, in the alternative, that a separate certification be

granted to Bandwidth and that CNT's certification be cancelled upon notice that the proposed

Transaction was completed. Furthermore, Bandwidth will adopt all of the tariffs (or make such

other filings as may be necessary in compliance with the laws of South Dakota) and will offer

service under the same rates, terms and conditions as are currently set forth in CNT's existing

tariffs. As a result, the Transactions will be transparent to prospective intrastate customers of CNT

and Bandwidth in terms of the services offered in South Dakota.

Bandwidth intends to provide local exchange and interexchange telecommunications services.

(7) 20:10:24:03(6) - A description of Applicant's experience providing any telecommunications services in South Dakota or in other jurisdictions, including the types of services provided, and the dates and nature of state or federal authorization to provide the services.

Bandwidth has not previously provided service in South Dakota but provides service in numerous states. As set forth in Section I.B of this Application, Bandwidth is authorized to provide telecommunications services in the following states: California, Florida, Georgia, Illinois, Kentucky, Michigan, Montana, New York, New Hampshire, North Carolina, North Dakota, Ohio, Pennsylvania, Texas and Washington. Bandwidth is in the process of obtaining similar authority to provide telecommunications services in all other states. Bandwidth is also authorized by the FCC to provide international and domestic interstate telecommunications services as a non-dominant carrier.

(8) 20:10:24:02(7) - Statement of how Applicant will provided services.

A detailed statement of how the Applicants will provide their services is described in Sections I and III of this Application.

(9) 20:10:24:03(7) - Names and addresses of Applicant's affiliates, subsidiaries, and parent organizations.

Applicant's parent is Bandwidth.com, Inc. and is located at the same address as Applicant.

(10) 20:10:24:02(8) and 20:10:24:03(9) - Narrative description indicating with particularity the geographic area proposed to be served.

Bandwidth seeks authority to provide local and interexchange telecommunications services to both business and residential customers. Initially, Bandwidth intends to provide local exchange service in the areas served by Qwest and does not plan to provide service in areas of any small or rural local exchange carriers. Bandwidth's exchanges will mirror those of the incumbent local exchange carrier (initially, only Qwest) in whose service territories Bandwidth will provide service, therefore, Applicants have not included a map showing proposed service areas. Bandwidth intends to offer interexchange services on a statewide basis.

(11) 20:10:24:02(9) and 20:10:24:03(12) - Financial statements.

The most recent financial statements for Bandwidth and Buyer are provided in Exhibit D to this Application.

(12) 20:10:24:02(10) and 20:10:24:03(17) - Complaints and regulatory matters.

The names, addresses, telephone number, facsimile number, E-mail address, and toll free number of Bandwidth's representatives to whom all inquiries must be made regarding complaints and regulatory matters are provided in Section IV of this Application.

In the event of a billing dispute, Bandwidth will perform a review of the disputed billing amount and attempt to reach a settlement to the mutual satisfaction of both parties. Following a full investigation to determine whether or not the charges are improper, Bandwidth may adjust the disputed bill. Because customer satisfaction is extremely important to Bandwidth and to its success in the competitive marketplace, all commercially reasonable efforts will be made to address and resolve customer concerns as quickly as possible.

(13) 20:10:24:03(10) - Technical competence.

Bandwidth is technically and managerially qualified to provide competitive local exchange and interexchange services in South Dakota. Bandwidth's South Dakota operations will be directed by its existing corporate management, technical and operations staffs who are responsible for the interexchange and local exchange operations in other states. Bandwidth will respond to customer complaints promptly using the personnel listed in Paragraph (12) and Section IV above. Bandwidth will perform facility and equipment maintenance necessary to ensure compliance with any commission quality of service requirements. Since Bandwidth will initially be providing service via resale, Bandwidth will initially rely on its underlying carriers to perform necessary facility and equipment maintenance.

(14) 20:10:24:02(11) and 20:10:24:03(18) - Bill and collect charges.

Bandwidth's customers will be billed directly by Bandwidth. Bandwidth's customer service number, 1-800-808-5150, will be provided on each customer's monthly bill.

(15) 20:10:24:03(11) - Information explaining how Applicant will provide customers with access to emergency services such as 911 or enhanced 911, operator services, interexchange services, directory assistance, and telecommunications relay service.

Bandwidth will comply with all applicable laws and regulations relevant to the provision of these services. Initially, Bandwidth will rely on its underlying carrier to provide such services.

(16) 20:10:24:02(12) and 20:10:24:03(19) - Information concerning Applicant's policies relating to solicitation of new customers and a description of the efforts the applicant shall use to prevent the unauthorized switching of interexchange and local service customers.

Bandwidth intends to market its services to business and residential customers in the State of South Dakota. Bandwidth plans to market its services directly through direct mail. In addition, Bandwidth may also utilize sales agents to solicit customers by telephone or in person. Bandwidth, however, has not yet developed brochures or other materials to be used in marketing its services in South Dakota. Bandwidth does not plan to engage in multi-level marketing in South Dakota. Bandwidth will comply with South Dakota law and the Federal Communications Commission's regulations governing changing a customer's primary carrier(s).

(17) 20:10:24:02(13) and 20:10:24:03(21) - Information concerning how Applicant will make available to any person information concerning the applicant's current rates, terms, and conditions for all of its telecommunications services.

Bandwidth will make its telecommunication rates, terms and conditions available to any person by making Bandwidth's tariffs available upon request at its office and by posting them online.

(18) 20:10:24:03(13) - Information related to interconnection.

Applicant is in the process of obtaining interconnection arrangements with Qwest Corporation.

(19) 20:10:24:02(14) and 20:10:24:03(22) - Information concerning how Applicant will notify a customer of any materially adverse change to any rate, term, or condition of any telecommunications service being provided to the customer.

Bandwidth will notify customers via mail 30 days in advance of materially adverse changes to any rate, term, or condition of any telecommunications service being provided to customer.

(20) 20:10:24:02(15) and 20:10:24:03(16) - A list of the states where Applicant is registered or certified to provide telecommunications services.

Bandwidth has never been denied registration or certification in any state and, furthermore, Bandwidth is in good standing with the appropriate regulatory agency in the states where it is registered or certified. As set forth in Section I.B of this Application, Bandwidth is authorized to provide telecommunications services in the following states: California, Florida, Georgia, Illinois, Kentucky, Michigan, Montana, New York, New Hampshire, North Carolina, North Dakota, Ohio, Pennsylvania, Texas and Washington. Bandwidth is in the process of obtaining similar authority to provide telecommunications services in all other states. Bandwidth is also authorized by the FCC to provide

international and domestic interstate telecommunications services as a non-dominant carrier.

(21) 20:10:24:03(15) - If the Applicant is seeking authority to provide local exchange service in the service area of a rural telephone company, the date by which the applicant expects to meet the service obligations imposed pursuant to § 20:10:32:15 and applicant's plans for meeting the service obligations

Bandwidth does not intend to provide local exchange service in the service area of a rural telephone company.

(22) 20:10:24:02(16) and 20:10:24:03(14) - A description of how the Applicant intends to market its services, and its target market.

As set forth in the response to (16) above, Bandwidth intends to market its services to business and residential customers in the State of South Dakota. Bandwidth plans to market its services directly through direct mail. In addition, Bandwidth may also utilize sales agents to solicit customers by telephone or in person. Bandwidth, however, has not yet developed brochures or other materials to be used in marketing its services in South Dakota. Bandwidth does not plan to engage in multi-level marketing in South Dakota. Bandwidth will comply with South Dakota law and the FCC's regulations governing changing a customer's primary carrier(s).

(23) 20:10:24:02(17) and 20:10:24:03(24) - Applicant's federal tax identification number and South Dakota sales tax number.

Bandwidth's federal tax identification number is 208326570. Bandwidth does not yet have a South Dakota sales tax number.

(24) 20:10:24:02(18) and 20:10:24:03(20) - Information regarding the number and nature of complaints filed against Applicant with any state or federal regulatory commission regarding the unauthorized switching of a customer's telecommunications provider and the act of charging customers for services that have not been ordered.

Bandwidth has not had any complaints filed against it in any state or federal regulatory commission regarding the unauthorized switching of a customer's telecommunications provider, nor for the act of charging customers for services that have not been ordered.

(25) 20:10:24:02(19) and 20:10:24:03(23) - Waiver of Commission's Rules.

To the extent necessary, Bandwidth requests a waiver of the local exchange map requirement in §§ 20:10:24:02(8) and 20:10:24:03(9) of the Administrative Rules of South Dakota. Bandwidth seeks authority to provide service statewide, and its local calling areas will mirror those of the incumbent carriers.

(26) 20:10:24:02(20) and 20:10:24:03(25) Other Information.

Further information for the Commission's consideration is provided in Section V of this Application.

# V. <u>PUBLIC INTEREST CONSIDERATIONS</u>

Applicants respectively submit that the proposed Transaction serves the public interest. The proposed transaction is expected to invigorate competition in South Dakota. The Transaction will provide Bandwidth a presence in the telecommunications market in South Dakota, and thereby make Bandwidth a more viable competitor in all of its markets, as it can attract customers that seek a carrier that can offer intrastate telecommunications services in multiple states.

The Transaction will not adversely impact South Dakota customers. Given that Bandwidth proposes to offer service on the same rates, terms and conditions of the services that CNT currently offers, Applicants expect the transaction to be virtually transparent to consumers and potential customers except for the change in the name of the carrier offering service.

# VI. <u>CONCLUSION</u>

For the reasons stated above, Applicants respectfully submit that the public interest, convenience, and necessity would be furthered by a grant of this Application. Accordingly, Applicants respectfully request expedited treatment to permit Applicants to complete the proposed transaction as soon as possible.



# Management Biographies for Bandwidth.com

### David Morken, Co-founder, Chairman and President

In his position as President of Bandwidth.com, Morken presides over the operations, legal, and product areas of the company at its offices in North Carolina.

In 1994, David Morken co-founded the Internet's first online tax filing service, efiling.com, which was acquired when he was called to active duty by the United States Marine Corps in 1995. From 1995 to 1999 he served as a Special Assistant U.S. Attorney, Criminal Prosecutor and Company Commander. He left active duty with the Marine Corps in June 1999 to found Bandwidth.com. Mr. Morken is a 1994 graduate of the University of Notre Dame Law School and member of the Virginia Bar Association. He received a B.A. from Oral Roberts University in 1991.

### Henry Kaestner, Co-founder, CEO

In his position as Chief Executive Officer of Bandwidth.com, Henry Kaestner presides over the operations of the company and its offices in Cary, North Carolina and Chicago, Illinois.

Previously, Mr. Kaestner was the CEO of Bandwidth International, an international wholesale telecommunications broker based in London, England, a firm that merged with Bandwidth.com in late 2000. He was also a founder of Chapel Hill Broadband, a US based consultant and broker that specializes in dark fiber and large wholesale transactions that was sold to Cantor Fitzgerald. Mr. Kaestner was a Founder and former President and CEO of Chapel Hill Brokers, an energy broker which achieved more than \$50 million in daily trade volume on more than 150 transactions, for clients including Morgan Stanley and Merrill Lynch. Chapel Hill Brokers was sold to APB Energy (now ICAP Energy) in 1999. Mr. Kaestner is a graduate of the University of Delaware with a degree in International Relations.

#### Steven Lacoff, Vice President, Product Management and Marketing
