Please consider this letter as an application for an amended Certificate of Authority to provide a local exchange service pursuant to SDCL 49-31-69.

We are enclosing a Revised Franchise Service Territory Map reflecting the new telephone service territory as a result of annexation of land by the City of Brookings, see Attachment 1. Also enclosed, is a copy of the City of Brookings Resolution No. 111-06 dated October 24th, 2006 and executed by the Mayor of the City of Brookings as set forth in Attachment 2. The legal description in the Resolution is the land that we wish to include in our Amended Certificate of Authority.




