ANSWER: I am attaching Exhibit D. Our email records show that Exhibit D was part of the transmittal that left our office for filing

2. Please explain what happened in McIntosh, West Ortonville, and Whitewood.

ANSWER: Midcontinent has never allocated much money to McIntosh or West Ortonville. In our filing last year in McIntosh Midcontinent showed a capital expense estimate of \$154 and operating expense of \$173. This year Midcontinent reports its actual 2007 to be \$151 in capital and \$168 in operating expenses. Our estimates to actual were very close.

In West Ortonville we had an estimate of \$293 capital expense and \$329 estimated operating expense but because of the lack of customers in the exchange Midcontinent did not have the need to invest revenue there.

Midcontinent does advertise in those communities but we just haven't had a response for our phone services in those communities. We have always had fewer than 6 phone customers.

Whitewood is not an ETC designated exchange.

3. Should Whitewood be included on Exhibit A? Please explain your response.

ANSWER: No, because Whitewood is not an ETC designated exchange per TC04-003
