APPLICATION

NovaTel Ltd., Inc., ("Applicant"), a Texas Domestic for profit Corporation, files this verified application respectfully requesting that the Public Utilities Commission of South Dakota ("Commission") issue an order that:

- (a) grants Applicant a Certificate of Authority to provide interexchange telecommunications services pursuant to SDCL 49-31-3.
- (b) grants competitive status to Applicant, and classifies the Applicant's services asCompetitive.

In support of its request, Applicant states:

A copy of the Applicant's Certificate of Authority to transact business in South Dakota issued by the Secretary of State of South Dakota is attached hereto as <u>Exhibit A.</u>

2. Applicant is a reseller of telecommunications services which provides resold dedicated point-to-point private line service and dedicated Internet access to business customers only. These circuits are used for the transport of data services only. The company provides bandwidth starting and T-1 (1.544 Mbps) and proceeds into the high speed optical carrier networks up to OC192.

Applicant respectfully requests authority to provide service to prospective business customers throughout the State of South Dakota.

- 3. Applicant provides customer assistance on a 24 hour a day, 7 days a week basis. Customers with questions regarding service or regulatory matters, may contact James Quail, at the company's toll-free number of 1-888-765-6682, or if a customer prefers to correspond with the company in writing, they may send correspondence to the company address at 11550 IH-10 West, Suite 110, San Antonio, TX 78230.
 - 4. Applicant will bill customers for charges directly.
- 5. Applicant will use fair and reasonable industry standards to maintain its no slamming policy of customers. Applicants' policy will require a signed letter of authorization from the customer. For phone orders, applicant will utilize a third party verification system, including the recording of the request and maintaining records of requests in the Applicants principal business office.
- 6. Applicant provides a proposed tariff which contains the rules and regulations applicable to the Applicant's customers, a description of services offered, and a list of rates associated with such services.

- 7. Applicant is currently operating in California, Florida, New Jersey and Texas. Applicant has not been denied authority, nor had authority revoked in any jurisdiction and is currently in good standing in each jurisdiction where it operates.
- 8. Applicant will market to business customers only. No mulit-level marketing plans will be used. The Applicant will not be offering any charity based programs. Standard FCC accepted methods of media outlet such as print, radio and television sources will be utilized
- 9. The Applicant has secured and F.E.I.N of 74-2969809 and will obtain a South Dakota Sales Tax Number upon approval a Certificate of Authority to offer its services in South Dakota.
 - 10. The Applicant has not had any complaints of slamming in any jurisdiction.
- 11. Applicant requests classification as a competitive telecommunications company within the State of South Dakota, and that its services are classified as competitive. Applicant believes that its proposed services will be subject to sufficient competition to justify a lesser degree of regulation. Granting of this applicant is in the public interest as it will allow greater price and service options for telephone users.


