
Dear Ms. Van Gerpen:

I am filing this letter on behalf of Native American Telecom, LLC in the above-entitled matter to address possible scheduling issues on the Motion to Compel that was filed last Friday. The Motion to Compel seeks to compel discovery responses from Native American Telecom, LLC.

Native American Telecom, LLC attempted to negotiate an extension to respond to the interrogatories with the Movant, but no extension was granted. This letter is to make the Commission aware that Native American Telecom, LLC is willing to extend the Commission's decision time and will be requesting the Commission grant Native American Telecom, LLC an extension to respond to discovery.
