VERIZON BUSINESS'S NOTICE OF WITHDRAWAL


MCI Communications Services, Inc. d/b/a Verizon Business Services ("Verizon Business") provides this notice of its withdrawal of its intervention and request that the Commission investigate and suspend the application of Qwest Corporation ("Qwest") to modify jurisdictional report requirements, which petition to intervene was filed in this docket on November 21, 2008.

Verizon Business does not object to or protest the revised tariff pages of Qwest filed in this docket with the Commission on July 6, 2009, as a result of Qwest's agreement to increase the floor to 7%, as specified in Section 2.3.10A of Qwest's revised tariff pages. In addition, Verizon Business has no objection to the inclusion of additional new and changed language in Section 2.3.10A and 2.3.10B.2.c set forth in Qwest's revised tariff pages.

WHEREFORE, Verizon Business respectfully requests that the Commission accept the within Notice of Withdrawal and allows Qwest's revised tariff pages filed on July 6, 2009, to become effective as proposed on July 14, 2009.


