Please accept this letter as notice that effective July 15, 2009, Talk America Inc. d/b/a Cavalier Telephone d/b/a Cavalier Business Communications is voluntarily relinquishing its authority to provide interexchange telecommunications services within the State of South Dakota.

Talk America was granted interexchange long distance authority in original Order Number TC 92-018 on June 16, 1992.

Currently the Company has sixteen (16) long distance customers in South Dakota which will be affected by this discontinuance. A written notice was sent via first class mail on May 27, 2009 to all affected customers. The Company has filed an application for discontinuance with the Federal Communications Commission pursuant to 47 C.F.R. §63.71, a copy of which is attached.

The Company is requesting that the interexchange tariff - SDPUC Tariff No. 2, currently on file with the Commission be withdrawn.

Section 63.17 Application of Talk America Inc. to Discontinue Services

Talk America Inc. ("Talk America" or "Applicant") hereby seeks authorization pursuant to Section 214 (a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, to discontinue its provision of domestic local and/or long distance telecommunications services (including intrastate, interstate and international) to end-user customers in fifteen (15) states. Talk America does business in some of the affected states under the name Cavalier Telephone. In other states, it also does business under the names Cavalier Business Communications (for business services) and Cavalier Telephone and TV.

Applicant is considered a non-dominant telecommunications carrier with respect to all of its services, including those affected by the proposed discontinuance. As detailed below, the Applicant currently serves a very limited number of customers in the states where it proposes to discontinue service. The Applicant will continue to provide telecommunications services in a number of other states not affected by this Application for discontinuance.

Talk America individually notified affected customers of its proposed discontinuance of service via letter sent first class mail on May 27, 2009.

The applicant provides the following information pursuant to Section 63.71 of the Commission's rules:

2. Date of Planned Service Discontinuance, Reduction or Impairment:

Talk America proposes to discontinue service to the affected customers on July 15, 2009, with the exception of customers in Iowa. The date of planned service discontinuance for Iowa customers is September 15, 2009.

3. Points of Geographic Areas of Service Affected:

Applicant proposes to discontinue the provision of all local and long distance services (including intrastate, interstate and international) in Arkansas, Kansas and Oklahoma. Applicant proposes to discontinue the provision of all long distance services (including intrastate, interstate and international) in South Dakota, Iowa, Idaho, Maine, North Dakota, Nebraska, New Mexico, Rhode Island, Utah, Vermont, Wyoming and West Virginia (the Applicant does not offer local services in these latter states).

4. Brief Description of Types of Service Affected:

Talk America will discontinue both retail local and long distance service. The number of impacted customers in each state for each type of service is listed in the following table:

5. Brief Description of Dates and Methods of Notice to All Affected Customers:

The Applicant has provided written customer notice of the planned discontinuance in accordance with the requirements of section 63.71 (a) of the Commission's Rules by notice dated May 27, 2009. Notice was provided via letter sent first class mail to each affected customer. Copies of the customer notices (one for Iowa and one for all other states) are appended hereto as Exhibit A.

Notice has been sent to the State Regulatory agencies, Governors' offices and the Department of Defense, as required under Section 63.71, concurrent with this filing. A service list is provided in Exhibit B.

Conclusion

Pursuant to Section 214 (a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, Talk America Inc. understands that this application will be automatically granted on the 31st day after the Public Notice is released, with no Commission notification to the Company, unless the Commission has notified the Company that the grant will not be automatically effective.
