Dear Ms. Van Gerpen:

OnStar, LLC ("OnStar"), by its undersigned counsel, hereby informs the Commission of the reorganization and exit from bankruptcy under Chapter 11 of the U.S. Bankruptcy Code of its parent company.

OnStar is authorized to provide resold Commercial Mobile Radio Services ("CMRS") in your state.¹

On June 1, 2009, OnStar's parent company, General Motors Corporation ("GM"), filed a voluntary petition for protection under Chapter 11 of the U.S. Bankruptcy Code in the U.S. Bankruptcy Court for the Southern District of New York.² OnStar itself was not a party to the bankruptcy proceeding.³

As part of its court approved plan to exit bankruptcy, GM transferred certain assets, including OnStar, to General Motors Company ("GMC") on July 10, 2009.⁴ Further, on

November 2, 2009, GMC changed its corporate structure and transferred direct ownership of OnStar from GMC to its wholly-owned subsidiary, General Motors Holdings LLC.⁵

A corporate chart indicating the current chain of ownership and control of OnStar is attached.

OnStar will continue to provide resold CMRS in your state without any change in the rates, terms or conditions of service. As such, OnStar expects that GMC's reorganization will have no effect on OnStar's customers in your state.


