Attached is a copy of Our Certificate of Authority, # FB033574, from the South Dakota Secretary of State as requested item 1-1 of your email. In addition, I have previously sent in a copy of our Minnesota Certificate of Good Standing with our application to South Dakota.

Item 1-2 regarding rate, term, and condition information, yes, DTI provides this information in full disclosure to customers prior to signing of a contract.

Regarding Item 1-3, DTI prevents unauthorized switching and utilizes PIC restricted controls of accounts and does not change customer service without customer approval.


Marketing brochures are attached in response to Item 1-4.

As per our conversation, DTI requests a Waiver on Item 1-5 relating to financial statements. DTI has been in business since 1998 and being privately held, does not disclose financial data. DTI has requested a Surety Bond quote which is in process however, this may take some time to obtain. A Waiver would be appreciated.

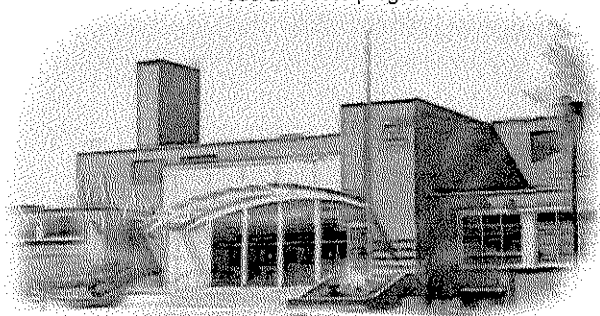

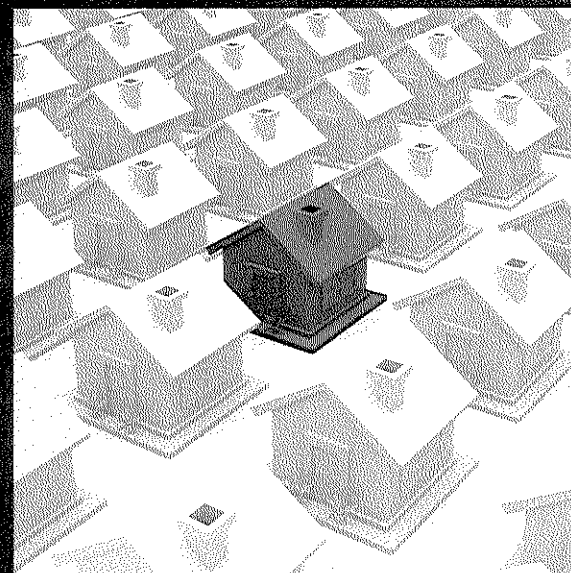

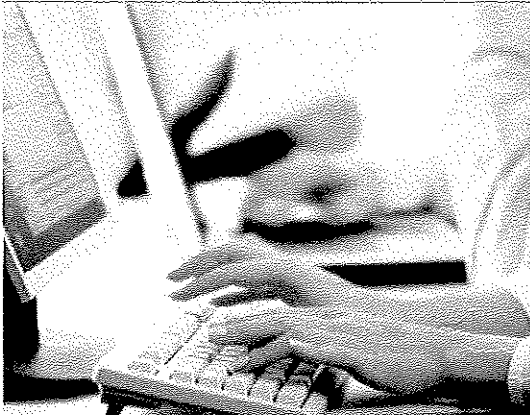
