SUPPLEMENT TO APPLICATION FOR APPROVAL OF AN AMENDMENT TO CERTIFICATE OF AUTHORITY

COMES NOW, the Applicant McCook Cooperative Telephone Company ("McCook") by and through its undersigned counsel, and pursuant to SDCL § 49-31-59 and 49-31-69, hereby supplements its request that the South Dakota Public Utilities Commission (the "Commission") approve an amendment to the Certificate of Authority held by McCook to permit it to offer local exchange service to the former customers of Tri-County Telcom, Inc. ("Tri-County") in the Emery and Clayton, South Dakota exchanges.

IN SUPPORT THEREOF, Applicant does state and declare as follows:

1. Applicant McCook currently has an existing Certificate of Authority on file with the Commission.

2. As a result of the reorganization contemplated in the application submitted to the Commission by Applicant McCook on October 6, 2009 (the "Application"), SDCL § 49-31-69 requires that the Certificate of Authority held by McCook be amended as follows:

(a) The Applicant's information required under ARSD 20:10:32:03(1) shall be modified as follows:

(b) Pursuant to ARSD 20:10:32:03(3), the name under which applicant will provide local exchange services shall be TrioTel Communications.

(c) The Applicant shall no longer have any affiliate or subsidiary organizations, and all such affiliates and subsidiaries currently listed in the Applicant's Certificate of Authority pursuant to ARSD 20:10:32:03(7), shall be deleted.

(d) The service area map indicating the geographic area proposed to be served by Applicant included in the Certificate of Authority pursuant to ARSD 20:10:32:03(9) shall include both the area currently served by McCook, as depicted in the exchange map attached hereto as Exhibit A and incorporated herein by this reference, and the area currently served by Tri-County, as depicted in the exchange map attached hereto as Exhibit B and incorporated herein by this reference, to reflect a cumulative geographic area to be served by the Applicant, as depicted by the shaded area shown in the map of the State of South Dakota attached hereto as Exhibit C and incorporated herein by this reference.

(e) Pursuant to ARSD 20:10:32:03(12), the financial statements of the Applicant for the most recent 12 month period are attached hereto as Exhibit D and incorporated herein by this reference. Applicant requests that Exhibit D be treated as confidential and not be disclosed to the public or any intervening parties.

WHEREFORE, Applicants respectfully request that the Commission grant as follows:

A. Approval of the sale, as defined by SDCL § 49-31-59 and set forth in the Application.

B. Amendment to the Certificate of Authority currently held by McCook (to be renamed TrioTel Communications, Inc.) as defined by SDCL § 49-31-59 and 49-31-69, and provided for herein; and

C. Such other relief, consents, or authorizations as the Commission deems necessary or appropriate and in the public interest to consummate the transactions described in this Application.
