Remaining Qwest Wireless Phone Customers Must Switch to a New Wireless Provider by Oct. 31

DENVER, Oct. 22, 2009 – Qwest will discontinue Qwest Wireless cellular phone service on Oct. 31, 2009, and is encouraging remaining Qwest Wireless customers to switch to a new wireless provider in advance of the Oct. 31 shutdown. Customers who do not transition to a new wireless service provider by Oct. 31 will have their Qwest Wireless service disconnected, and will forfeit their Qwest Wireless phone number.

Key Facts:

- Qwest Wireless phone numbers are portable until Oct. 31. Customers who switch to a new service provider by Oct. 31 will be able to port their wireless phone numbers to that new provider.
- Qwest Wireless customers who do not switch their wireless service to another carrier by Oct. 31 will have their service disconnected, and will not be eligible to port their Qwest Wireless telephone number to another provider.

- There is no early termination fee when disconnecting Qwest Wireless service.
- Qwest has provided Qwest Wireless customers multiple notifications to transition their wireless service to another wireless provider.

• NOTE: The shutdown only impacts Qwest Wireless cellular phone service, and will have *no impact* on Qwest high-speed Internet home wireless networks.
