APPLICATION

Pursuant to SDCL §§ 49-31-70 through 76 and ARSD ¶ 20:10:32:03, South Dakota Network, LLC ("SDN") provides the following information in support of this application for a Certificate of Authority ("COA")to provide local exchange service in Qwest Corporation ("Qwest") service areas in South Dakota:

1. The applicant's identifying information is:

- 2. SDN is a South Dakota limited liability company owned and managed by a board of managers from the rural local exchange companies ("RLEC") in South Dakota.
- 3. Services will be provided by SDN Communications.
- 4. SDN's principal office is located as described in paragraph 1, above. The registered agent is Darla Pollman Rogers, 319 South Coteau Street, Pierre, SD 57501-3187
- 5. A copy of SDN's certificate of authority to transact business in South Dakota is attached as Exhibit A.
- 6. SDN started in the telecommunications business 20 years ago to provide centralized equal access service ("CEAS") and tandem switching services to its RLEC owners and intra and interstate interexchange carriers to originate and terminate long distance traffic from and to end user customers in the RLEC service areas. In the intervening years SDN has expanded its service offerings to include Internet service, regional dedicated data transport, network surveillance, broadband services and connectivity, colocation, network equipment, telephone systems, cabling services, and a cable TV headend. The SDN Internet website contains more detailed information (www.sdncommunications.com). SDN also manages and operates a long distance reseller, Express Communications, Inc., for its RLEC owners. SDN recently built and now operates and manages the South Dakota Research Education Economic Development (REED) state-wide network connecting the state's universities, the deep underground laboratory and the EROS Data Center with regional and national data networks using the latest in high speed data transport. SDN is certified/registered and provides services in the following neighbor states:

- a. Minnesota certified to provided CEAS for South Dakota RLECs that provide local exchange service to Minnesota communities (December 27, 1991), to provide local niche services (Internet, dedicated data transport and broadband services generally) (February 25, 2009), and will be filing an application for a COA to provide CLEC and additional tandem services.
 - b. North Dakota registered to provide all services (August 27, 2009)
 - c. Iowa registered to provide Internet and data transport services (November 24, 2008)
- d. Nebraska registered as a Communications Provider (VoIP) and Information Service Provider (Internet and data transport) (November 19, 2008).
- e. Wyoming attempted to register as an Internet and data transport provider, but informed by the PSC that the PSC does not regulate those services and that registration was not permitted (November 28, 2008).

SDN has blanket domestic 214 authority from the FCC pursuant to 47 CFR § 63.01.

- 7. SDN has ownership interests in Northern Hills Transport, LLC and SDN Technologies, LLC, both of which are located at the address in paragraph 1, above. SDN also has an ownership interest in the West Central Transport Group, Inc., which is a fiber network in central and southern Minnesota currently located with and managed by 702 Communications, 702 Main Avenue, Moorhead, MN 56560. SDN does not have any subsidiaries.
- 8. SDN seeks to provide authority to provide local exchange voice services to business customers through voice over Internet protocol (VoIP) or through use of unbundled network elements or resale of voice service provided by Qwest. Voice services will be provided on an individual case basis ("ICB") at customer request as an adjunct to Internet and other broadband service provided by SDN. SDN will utilize its own broadband network and soft switch whenever possible to provide VoIP. SDN will also utilize local DSL loops from Qwest to provide such services when necessary. All interoffice transport will be on SDN's and SDN's owners' networks wherever possible and Qwest's network where necessary and available. SDN will provide whatever calling features (e.g. call waiting, call forwarding, caller id, etc.) the customer requests. SDN provides long distance services through Express Communications, Inc., a reseller owned by the owners of and managed by SDN.
- 9. SDN will offer service only within the Qwest local exchange boundaries in the state of South Dakota, the maps for which are already on file with the Commission.
- 10. a. Short biographies of the senior management describing each individual's education and telecommunications background are attached as Exhibit B. The management of SDN has significant experience in the switching and provisioning of local exchange service. Additionally, SDN employs nearly 100 technical personnel who have extensive knowledge and experience in engineering, installing, operating, billing and troubleshooting telecommunications facilities, equipment and end user services. SDN has been supporting the provisioning of local exchange and long distance service since its inception.
- b. SDN's network and the networks of its owners and customers are monitored 24x7x365 by a Network Surveillance Center ("NSC") staffed by skilled and well-trained telecommunications technicians. In addition to its own outside plant and service engineers, SDN also has access to technicians and support personnel of its owners, who cover the entire geography of the state and who will

respond to service disruptions and network problems upon NSC notification. SDN also has an 800 number (800-247-1442) and web access at www.sdncommunications.com for customer service.

- 11. SDN will utilize Qwest and other vendors for the provisioning of 911 and E911 services, operator services, directory assistance, and telephone relay service. Interexchange service will be provided as described in paragraph 8, above.
- 12. An audited financial statement is provided in Confidential Exhibit C. SDN is not a public company.
- 13. SDN will interconnect with Qwest and is in the process of negotiating and interconnection agreement with it. Notice of a desire to negotiate an agreement was sent on March 9, 2010. Copies of the email request and responses are attached as Exhibit D. SDN intends to opt-in to an existing agreement and it will be expeditiously completed and filed with the Commission.
- 14. SDN does not intend to market its voice service except by reference and description on its Internet website. Service will be provided as part of a bundle of data and Internet services and will be provided pursuant to contract.
- 15. SDN will not provide local exchange service in the service area of a rural telephone company.
- 16. See the response to paragraph 6, above, as to where SDN is registered and certified. SDN has not been denied registration or certification in any state and is in good standing in every state where it is registered or certified.
- 17 Customers may complain or they and others may inquire as to complaints and other regulatory matters to the following:

- 18. Local Exchange service billing and any required taxes and fees will appear in a separate section of the customer's monthly bill for the data and Internet service that are a part of the service package. The amount billed will be prospective and due and payable within 30 days of the billing date.
- 19. Service will be provided under contract and only as part of a package of other services. SDN will require a letter of agency ("LOA") from the customer if the provisioning of the local exchange or interexchange service results in an incumbent or other competitive carrier losing the customer for its local exchange and/or long distance service.
- 20. SDN has not had a complaint filed against it in any state or federal commission for the unauthorized switching of a customer's telecommunications provider or for charging customers for services they had not ordered.
- 21. Information on SDN's rates and terms and conditions of service are available upon request. All services are provided under contract. SDN does have on its Internet website an Acceptable use Policy

("AUP"), which applies to service provided by SDN. The AUP will be modified to include local exchange services prior to SDN offering such services.

- 22. Services are offered only under contract. Changes in rates or terms and conditions of service can only be changed as stated in the contract and only in writing as the parties mutually agree to.
- 23. SDN requests a Commission waiver of the following rules:
- a. ARSD ¶ 20:10:32:06.01 Performance bonds. SDN is a long standing provider of telecommunications services in the state. As is evident from the financial information provided in Confidential Exhibit C, SDN operates a sound business and there is no need for any security to ensure customer welfare regarding the provisioning of or payment for any service.
- b. ARSD \P 20:10:07:03 Transmittal of bills. SDN provides its bills in electronic format and itemized as required by this rule. The customers are medium to large business that require that billing format finding more efficient than providing large stacks of paper. Paper bills or portions thereof can be provided upon request.
