James Valley Wireless, LLC ("JVW"), a South Dakota limited liability company, by and through its counsel of record, hereby files its Petition to Intervene in this docket. In support of its Petition, JVW states as follows:

1. JVW is a South Dakota limited liability company with its principal place of business in Aberdeen, South Dakota. It is a telecommunications company as defined by SDCL 49-31-1(35) authorized by the Commission to provide telecommunications services within its certified service territory in South Dakota.

2. JVW was first designated as an Eligible Telecommunications Carrier (ETC) by this Commission on November 17, 2006 (TC06-077).

3. As a CETC, JVW has a direct and immediate pecuniary interest in this Commission's decision in this docket.

4. The Intervention Date in this docket was September 24, 2010. Although this Petition is late filed, under ARSD 20:10:01:15.02 "petition to intervene which is not timely filed ... may be granted ...if granting the intervention will not unduly prejudice the rights of other parties to the proceeding or if denial of the petition is shown to be detrimental to the public interest."

There has been no activity in this docket, except for the petitions to intervene by South Dakota Telecommunications Association and Golden West Telecommunications Cooperative, Inc. and

therefore, there is no prejudice to any party.

WHEREFORE, JWV requests that its Petition for Leave to Intervene be granted.
