

Cellco Partnership d/b/a Verizon Wireless (“Cellco”), on behalf of itself and its subsidiaries and affiliates offering commercial mobile radio services (“CMRS”) in the State of South Dakota (collectively, “Verizon Wireless”), specifically including WWC License, LLC, successor to GCC License Corporation (“WWC”), hereby moves the Public Utilities Commission of South Dakota (“Commission”) for approval of the partial relinquishment of WWC’s eligible telecommunications carrier (“ETC”) status -- specifically for the service area encompassed by Golden West Telecommunications Cooperative, Inc.’s (“Golden West”) Study Area Code (“SAC”) 391659 -- to be deemed effective immediately.

As demonstrated by the Petition in this matter, each of the requirements set forth in 47 U.S.C. § 214(e)(4), 47 C.F.R. § 54.205 and A.R.S.D. 20:10:32:48 have been satisfied. Accordingly, the provisions of federal and state law provide that the Commission “shall” permit WWC to partially relinquish its ETC designation as requested and without delay.


