### AVENTURE'S PRE-FILED DIRECT TESTIMONY OF

#### JIM McKENNA

\_\_\_\_\_

Aventure Communication Technology, L.L.C. ("Aventure") submits the following direct testimony of Jim McKenna.

Jim McKenna, after first being duly sworn on oath, testified as follows:

- 1 Q. Could you state your name.
- 2 A. Jim McKenna.
- 3 Q. And how are you employed?
- 4 A. I am Chief Executive Officer for Aventure Communication Technology, L.L.C.
- 5 Q. How long have you been CEO of Aventure?
- 6 A. Since 2005.
- 7 Q. Could you describe for the Commission your background and experience in the
- 8 telecommunications industry?
- 9 A. In 1974, I went to work for Northwest Iowa Telephone of Sergeant Bluff, Iowa and I was
- with that company for 25 years eventually assuming the position of president. In approximately
- 11 1999, I started a CLEC in Sioux City and the name of that company was FiberCom. FiberCom

- 1 continues to exist in Sioux City today. In early 2005, I approached the FiberCom board with the
- 2 idea of creating a network where the "last mile" to the consumer would be via WIMAX
- 3 Broadband Wireless Technology as opposed to the traditional wire line connection. The
- 4 FiberCom board was hesitant to adopt the concept so I sold my interest in FiberCom and helped
- 5 start a new CLEC which was Aventure Communication Technology, L.L.C.
- 6 Q. So Aventure was a startup CLEC in 2005?
- 7 A. Yes.
- 8 Q. Has Aventure obtained a Certificate of Public Convenience and Necessity in South
- 9 Dakota.?
- 10 A. Yes.
- 11 Q. When was that Certificate issued?
- 12 A. In 2007.
- 13 Q. Is Aventure's South Dakota Certificate in good standing?
- 14 A. Yes.
- 15 Q. When did Aventure first file tariffs in South Dakota?
- 16 A. Aventure filed its local exchange telecommunications services tariff effective January 9,
- 17 2007. It also filed its initial intrastate access tariff in South Dakota at that time.
- 18 Q. Why is Aventure seeking to amend its intrastate access tariff in South Dakota?
- 19 A. On December 14, 2010, we filed a new interstate access tariff with the FCC and that tariff
- became effective December 31, 2010. We have filed this new South Dakota tariff in an effort to
- 21 maintain consistency in terms and conditions of service between our interstate tariff and our
- 22 intrastate tariffs. It made sense to us to have identical definitions and terms of service in our
- 23 tariffs to avoid customer confusion.

- 1 Q. Does Aventure utilize a consultant for tariff preparation and filing?
- 2 A. Yes, we use Technologies Management, Inc. to develop and file our tariffs. To our
- 3 knowledge, they utilize definitions, terms and conditions that are common in the industry and
- 4 used by TMI in a number of their other carrier clients.
- 5 Q. Does Aventure currently have any facilities in South Dakota?
- 6 A. No.
- 7 Q. Does Aventure currently have any customers or end users in South Dakota?
- 8 A. No.
- 9 Q. Does Aventure have plans to expand into South Dakota?
- 10 A. Yes. Current business plan is to develop facilities, and hopefully customers, in southeast
- 11 South Dakota along with northeast Nebraska. Areas of North Sioux City, Jefferson and Elk
- Point are closest to our base of operations in northwest Iowa and we would anticipate developing
- a network to serve those areas with WIMAX Broadband Wireless Technology for telephone
- service and internet access. Eventually, we would also like to serve Vermillion and Yankton and
- 15 associated rural areas. We do not have a definitive timetable for building out a South Dakota
- 16 network.
- 17 Q. If this pending tariff is approved, what intrastate access rate would Aventure charge for
- intrastate access services in South Dakota?
- 19 A. Our intrastate rate mirrors our interstate rate for switched access services and that rate is
- approximately 5.2 cents per minute of use.
- 21 Q. Do you know how that rate would compare with the Qwest rate for intrastate switched
- 22 access service in South Dakota?
- A. I believe our tariffed rate is slightly lower than the Owest intrastate switched access rate.

- 1 Q. Does Aventure have a current business plan that reflects its proposed service in South
- 2 Dakota?
- 3 A. Yes. Our current business plan has been introduced into evidence as Aventure Exhibit 1.
