Native American Telecom, LLC ("NAT") requests the Commission postpone the decisions scheduled for its next meeting on Tuesday, November 8, 2011, regarding the various parties' Petitions to Intervene in the above-referenced matter. This item is listed in the telecommunications part of the Commission's agenda under item number 3.

On October 11, 2011, NAT filed its Application for Certificate of Authority with the Commission. The Commission then established an Intervention date of October 28, 2011. Since filing its Application for Certificate of Authority, NAT received the following intervention petitions:

6. CenturyLink's/Qwest's Re-filed Petition for Intervention (11-1-2011).


