Include your financial statements (unaudited and audited if available) and those of your Affiliates, including Balance Sheets, Income Statements, and Statements of Cash Flow, for 2009 and 2010.

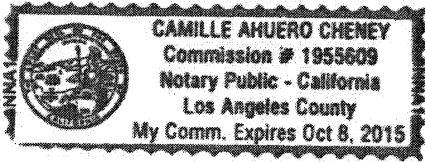
