Liberty-Bell Telecom, LLC (the "Company") notifies the South Dakota Public Utilities Commission ("Commission") that effective April 11, 2011, the Company is doing business under "DISH Network Phone & Internet." Evidence is attached of name assumption registration with the Office of the Secretary of State for the State of South Dakota.

On August 2, 2010 the Company was granted a *Certificate of Authority* with the Commission in Docket No. TC10-081. The Company's name assumption follows acquisition of a controlling interest in the Company's parent company, Liberty-Bell, LLC, by DISH Media Holdings Corporation, a wholly-owned subsidiary of DISH Network Corporation. Notice of the acquisition was provided to the Commission on November 12, 2010. Neither the acquisition of Liberty-Bell, LLC nor the Company's assumption of the DISH Network name will otherwise affect the Company's operations. The Company does not currently serve any customers in South Dakota. Accordingly, no separate customer notice is required.

The Company proposes to begin providing telecommunications services in the State of South Dakota as "Liberty-Bell Telecom, LLC dba DISH Network Phone & Internet" effective April 20, 2011.


