RE: Notice of De-tariffing of Common Carrier Broadband Internet
Access Transmission Service Effective July 1, 2011

This is an informational notice as required by the Federal Communications Commission (FCC), *no action is necessary on your part*, that James Valley Cooperative Telephone Company (James Valley) will discontinue providing Digital Subscriber Line Access Service on a tariffed basis. Effective July 1, 2011, James Valley will no longer have its own Tariff filed with the F.C.C., Tariff No. 1, for Digital Subscriber Line Access Service. However, the services will be offered on a de-tariffed Title II Common Carrier basis.

James Valley serves the towns of Groton, Andover, Bristol, Claremont, Columbia, Conde, Doland, Ferney, Frederick, Hecla, Houghton, Mellette and Turton in South Dakota and its nearby areas within the James Valley exchanges. The provisioning of services for your current Digital Subscriber Line Access Service is not changing. However, effective July 1, 2011, the DSL Service Guide will be available for public inspection on our website at www.jamesvalley.com and at our office located at 235 East First Avenue, Groton, SD 57445.


Dear Ms. Dortch:

Pursuant to the *Wireline Broadband Order*¹, James Valley Cooperative Telephone Company (James Valley), files the enclosed notice of intent to discontinue its wireline broadband access service offering under James Valley F.C.C. Tariff No. 1 effective July 1, 2011. James Valley will provide Digital Subscriber Line Service on a de-tariffed common carrier basis effective July 1, 2011.

James Valley has notified its current affected customers per the attached memo dated May 25, 2011. The geographic areas James Valley serves are the towns of Groton, Andover, Bristol, Claremont, Columbia, Conde, Doland, Ferney, Frederick, Hecla, Houghton, Mellette and Turton in South Dakota and the nearby areas outside of the towns within its own telephone exchanges. There will be no significant change to its customers with James Valley's choice to de-tariff its DSL services as the provisioning of these services will not be affected by this decision. Effective July 1, 2011, the terms and conditions under which DSL will be offered by James Valley will be posted for public inspection on its website at www.jamesvalley.com and a physical copy of the offerings will be available at its office, located at 235 East First Avenue, Groton, SD 57445.


