APPLICATION

Application is hereby made to the South Dakota Public Utilities Commission ("Commission") pursuant to ARDS 20:10:32:03 for an Order granting TC Systems, Inc. ("Applicant") a Certificate of Authority to provide Local Exchange Services in the State of South Dakota. The following information is furnished in support thereof:

1. Applicant's name, address, telephone number, facsimile number, web page URL and e-mail address:

2. A description of the legal and organizational structure of the applicant's company:

TC Systems, Inc. is a Delaware corporation. A certified copy of TC Systems' Articles of Incorporation and amendments thereto is attached as Exhibit A.

3. The name under which applicant will provide local exchange services if different than in subdivision (1) of this section:

TC Systems, Inc. will be the entity providing wholesale local exchange service in South Dakota. It does not intend to provide retail local exchange service at this time.

4. The location of the applicant's principal office, if any, in this state and the name address of its current registered agent, if applicable:

The Applicant has no principal office located in the State of South Dakota. The name and address of Applicant's current registered agent is:

6. A description of the applicant's experience providing any telecommunications services in South Dakota or in other jurisdictions, including the types of services provided, and the dates and nature of state or federal authorization to provide the services:

Applicant was organized under the laws of the State of Delaware on September 20, 1989. Applicant is an indirect subsidiary of AT&T, Inc. and an affiliate of AT&T Communications of the Midwest, Inc., as well as AT&T Mobility LLC. AT&T, Inc. is the ultimate parent corporation of TC Systems, Inc., AT&T Communications of the Midwest, Inc. and AT&T Mobility LLC. AT&T, Inc., on its own and through a number of subsidiaries, is authorized to provide domestic and international telecommunications services throughout the United States. In addition, AT&T, Inc. is authorized under a number of subsidiaries, including TC Systems, Inc., to provide local exchange service in all 50 states.

7. Names and addresses of applicant's affiliates, subsidiaries, and parent organizations, if any:

TC Systems, Inc. is a wholly-owned subsidiary of TCG New York, Inc., a Delaware corporation ("TCG NY"). TCG NY is in turn wholly-owned by Teleport Communications Group Inc., a Delaware corporation ("Teleport"). Teleport is a

wholly-owned subsidiary of AT&T Corp., a New York corporation, and AT&T Corp is a wholly-owned subsidiary of AT&T Inc., a Delaware corporation.

- 8. A list and specific description of the types of services the applicant seeks to offer and how the services will be provided including:
 - a. Information indicating the classes of customers the applicant intends to serve:

Applicant will provide wholesale local exchange service to one of its affiliates.

b. Information indicating the extent to and time-frame by which applicant will provide service through the use of its own facilities, the purchase of unbundled network elements, or resale;

Applicant will offer services through the purchase of unbundled network elements via an interconnection agreement with CenturyLink.

c. A description of all facilities that the applicant will utilize to furnish the proposed local exchange services, including any facilities of underlying carriers; and

Applicant will provide transport service, along with telephone numbers, direct inward dialing service and direct outward dialing service between the public switched network and its affiliate. Applicant is planning to enter into an interconnection agreement with CenturyLink.

d. Information identifying the types of services it seeks authority to provide by reference to the general nature of the service;

Applicant will provide wholesale local exchange service to one of its affiliates.

9. A service map or narrative description indicating with particularity the geographic area proposed to be served by the applicant:

Applicant intends to provide wholesale local exchange service to one of its affiliates in the service area of CenturyLink.

Applicant is an indirect affiliate of a global telecommunication corporation that provides domestic and international telecommunications services that has customer service bureaus to respond to customer inquiries and maintenance groups that ensure appropriate service levels are provided for its customers.

11. Information explaining how the applicant will provide customers with access to emergency services such as 911 or enhanced 911, operator services,

interexchange services, directory assistance, and telecommunications relay services;

The affiliate, whom the Applicant's will be providing wholesale local exchange service functionality to, will provide its own 911 functionality, operator services, interexchange services, directory assistance and telecommunications relay services.

12. For the most recent 12 month period, financial statements of the applicant consisting of balance sheets, income statements, and cash flow statements. The applicant shall provide audited financial statements, if available;

Applicant is not a publicly traded company. Attached is a copy of AT&T, Inc.'s 2010 Annual Report, which is attached as Exhibit D.

Applicant, immediately after filing its application for a Certificate of Authority with the South Dakota Public Utilities Commission, will request to opt-in to an existing interconnection agreement with CenturyLink.

Applicant will provide its wholesale local exchange services to one of its affiliates and does not intend on marketing to any other customer.

Applicant is not seeking authority to provide local exchange service in the service area of any rural telephone company.

Applicant will not be serving retail local exchange customers. Applicant's affiliate will comply with all with all federal and state rules/regulations regarding changing a customer's local exchange service provider.

20. The number and nature of complaints filed against the applicant with any state or federal commission regarding the unauthorized switching of a customer's telecommunications provider and the act of charging customers for services that have not been ordered;

Applicant has not had any complaints filed against it regarding the unauthorized switching of a customer's telecommunications provider or for charging a customer for services that they had not ordered.
