On proposed page 18, section 2.3.3 (E) uses 20 days for submission of information and on proposed page 22, section 2.3.3 (G) (e) the language states 15 days for submission of information. Is there a discrepancy?

Request 14:

On proposed page 43, section 3.1.1(C)(3), paragraph 2 refers to "The Design Change Charge", "found in Section 5.1.1", yet there is no such rate in Section 5.1.1. Also, in paragraph 3, a "Service Date Change Charge" is mentioned with no corresponding rate. Please correct these discrepancies.

On proposed page 43, section 3.1.1(C)(4), paragraph 1 refers to "Expedited Order Charge found in Section 5.1.1", yet there is no such rate in Section 5.1.1. Please correct this discrepancy.

Request 16:

On proposed page 43, section 3.1.1(D)(1), paragraph 2, refers to "(B) following", yet there is no section "B following". Please correct this discrepancy.

On proposed page 53, section 4.3.2(E), please correct the first sentence (paragraph) so that it is a complete sentence.
