**Data Request No. 1-1:** Have all of TC Systems's access services invoices to date used intrastate rates which match their interstate rates?

**Response:** Yes, intrastate access service invoices issued by TC Systems to date have been billed at intrastate rates which are the same as the rates set forth in the Company's Federal Access Tariff.
