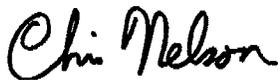

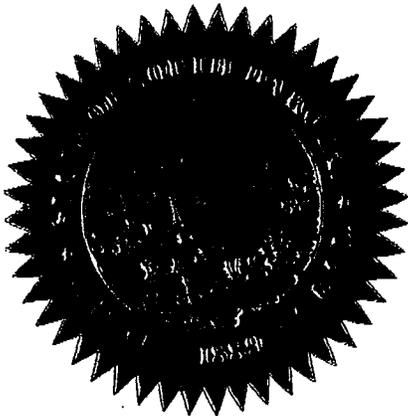

Pursuant to the provisions of SDCL § 47-1A-1007.01, the undersigned corporation is providing this Certificate Regarding the Articles of Restatement of Stockholm-Strandburg Telephone Co. in reference to the Articles of Restatement filed by the Corporation in the Office of the Secretary of State of the State of South Dakota on or about February 2, 2006.

FIRST: The name of the Corporation is Stockholm-Strandburg Telephone Co.

SECOND: The Restated Articles of Incorporation of Stockholm-Strandburg Telephone Co. filed in the Office of the Secretary of State of the State of South Dakota on or about February 2, 2006, consolidate all amendments to the Articles of Incorporation of the Corporation into a single document.

THIRD: all prior existing Articles of Incorporation of Stockholm-Strandburg Telephone Co., as well as any amendments thereto are hereby rescinded and restated in their entirety as follows:

ARTICLE I

The name of the corporation is Stockholm-Strandburg Telephone Co.

ARTICLE II

The period of existence of the corporation is perpetual.

ARTICLE III

FIFTH: These amendments to the Articles of Incorporation of Stockholm-Strandburg Telephone Co. were adopted on February 1, 2006.

SIXTH: The number of shares of the corporation outstanding at the time of such adoption was One Thousand (1,000), and the number of shares entitled to vote thereon was One Thousand (1,000).

SEVENTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

NINTH: The manner in which the exchange, reclassification, and cancellation of issued shares provided for in the amendments shall be effected as follows:

The existing shares of Stockholm-Strandburg Telephone Co. will be converted into the right to receive merger consideration and the existing capital stock of ITC Capital, Inc. will be converted into the new shares of the capital stock of Stockholm-Strandburg Telephone Co., all in accordance with the provisions of the Agreement and Plan of Merger, dated as of November 15, 2005, and entered into by and among ITC Capital, Inc., Stockholm-Strandburg Telephone Co., *et al.*

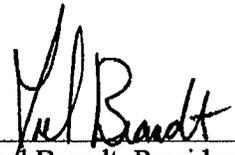
TENTH: The manner in which such amendments effect a change in the amount of stated capital, and the amount of stated capital changed by such amendments is as follows:

These amendments change the amount of stated capital of Stockholm-Strandburg Telephone Co. by lowering the amount of stated capital from the original amount of Five Thousand Dollars (\$5,000.00) to the new amount of One Thousand Dollars (\$1,000.00).

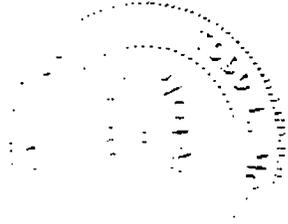

Pursuant to the provisions of SDCL §§ 47-1A-1007 *et seq.*, the undersigned corporation adopts the following Articles of Restatement.

FIRST: The name of the corporation is Stockholm-Strandburg Telephone Co.

SECOND: The following amendments and restatement of the Articles of Incorporation were adopted by the shareholders of the Corporation on February 1, 2006, in the manner prescribed by the South Dakota Business Corporation Act as codified at SDCL Chapter 47-1A. The Articles of Incorporation are hereby amended and restated in their entirety as follows:

ARTICLE I

The name of the corporation is Stockholm-Strandburg Telephone Co.

ARTICLE II

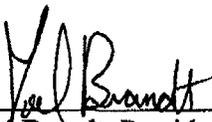

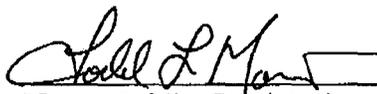
