RE: Notice of Name Change - Long Lines Metro, LLC f/k/a CommChoice, LLC

Dear Ms. Van Gerpen,

Long Lines Metro, LLC ("Long Lines"), formerly known as CommChoice, LLC, respectfully submits this informal notice of name change to the South Dakota Public Utilities Commission ("Commission").

CommChoice, LLC was granted certificate of authority to provide telecommunications service in South Dakota on June 10, 1997 in TC97-035. The current tariff on file for intrastate switched access service, No. 2, became effective on August 15, 1997. CommChoice, LLC legally changed its name to Long Lines Metro, LLC effective October 31, 2001.

In order to implement the Federal Communications Commission's ("FCC"), November 18, 2011, Intercarrier Compensation Reform Order, it was discovered that the effective tariff still on file with the Commission is under the Long Lines former name of CommChoice, LLC. This letter is to notify the Commission of the finding and rectify the issue.

The name change was not a result of corporate reorganization or a change of control. There was no change in operations and the transition was seamless to customers, which did receive notice.

A copy of the Amended Certificate of Authority received from the Secretary of State's Office as well as the amendment to certificate of formation changing its legal name is enclosed from the Delaware Secretary of State's office. Long Lines will file a revised intrastate switched access tariff reflecting the new name under a separate filing.

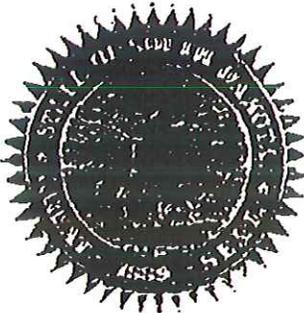
