SECTION 63.71 APPLICATION OF MCI COMMUNICATIONS SERVICES, INC. D/B/A VERIZON BUSINESS SERVICES INC.

MCI Communications Services, Inc. d/b/a Verizon Business Services (collectively "MCI") submits this Application for authority under Section 214(a) of the Communications Act and Section 63.71 of the Commission's rules to discontinue provision of its "MCI 900 Service," a transport service for 900 numbers. Consistent with Sections 63.71(a) and (b) of the Commission's rules, MCI provides the following information:

1. Name and Address of Carrier (47 C.F.R. §§ 63.71 (a)(1), (b)(2)):

MCI Communications Services, Inc. d/b/a Verizon Business Services One Verizon Way Basking Ridge, NJ 07920

2. Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):

MCI plans to discontinue its provisioning of 900 number transport service on or after June 30, 2013.

3. Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (b)(2)):

MCI will discontinue these services in all fifty states, the District of Columbia, and the U.S. territories, including Puerto Rico and the U.S. Virgin Islands.

4. Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(4), (b)(2)):

MCI 900 Service is an inbound, long distance transport service used to support third-party pay-per-call services.¹ The service allows a customer to charge end-users on a per-call basis when they call a pre-determined 900 number. The customer's charges to the third parties may be per-minute, flat-fee, or both. The MCI 900 Service is offered on a non-dominant basis.

Though once popularly used to obtain information (e.g., winning lottery numbers) or for entertainment (e.g., fan clubs and horoscopes) as well as other uses, 900 number usage has dropped substantially over time. In recent years, call volume and the number of unique numbers called have both dropped substantially. Currently, only two customers are purchasing this service from MCI. Overall call volumes have dropped by more than 80% in the past year. Moreover, there are now less than fifteen unique 900 numbers billed under this service that report more than 100 calls per month (down from more than ninety a year ago).

Increased use of mobile phones and access over the Internet to information once found via 900 numbers may be significant factors for the decline. Since mobile phones cannot be used to place 900 number calls, consumers who have either cut the cord or who primarily use cellular phones often now seek other options. Providers may offer mobile users information similar to that accessible over a 900 number using pay-per-use pound codes, in which a user dials the pound (#) sign plus a short number. Additionally, much of the same type of information previously accessed by 900 numbers is now obtainable over the internet or via social media. Other providers may offer information using an 800 number, with services billed to the user at the time of a call via the caller's credit card.

Due to the decline is usage of these services and the ready alternatives available, MCI plans to discontinue its provision of 900 number transport service on or after June 30, 2013.

¹ MCI no longer provides billing or collections services for 900 numbers.

Customers will face no impairment from this change. As noted above, the number of users has dropped dramatically, as end-users shift to alternate services or providers. Additionally, other entities have been assigned 900 number blocks, including entities such as North County Communications, Fastrack Global Billing Networks, Inc., PrimeTel Communications, and ACI Communications Holdings. Consequently, the public convenience and necessity will not be impaired by this discontinuance.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71 (b)(3)):

MCI sent notices to the two affected customers by overnight delivery on or before April 29, 2013. A copy of the notice sent to the affected customers is attached as Exhibit A.

MCI is sending copies of this Application by first class U.S. Mail to the governor and public utilities commission for each affected state and U.S. territory as well as to the Special Assistant for Telecommunications to the Secretary of Defense, as required by Section 63.71(a) of the Commission's rules.

6. Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

MCI is considered non-dominant with respect to the services to be discontinued.

CONCLUSION

MCI respectfully requests that the Commission approve this Application.

If you wish to object, you should file your comments as soon as possible, but no later than fifteen (15) days after the Commission releases public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the §63.71 Application of MCI Communications Services, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.

Again, MCI apologizes for any inconvenience you may experience due to this discontinuance.

Your business remains important to MCI and MCI looks forward to addressing and serving your future telecommunications needs.
