

**UNSERVED AREAS**




### **Unserved Area UA1**




UA1 is Section 19 of Township 2 North, Range 1 East, in northwestern Pennington County. It is surrounded by the Hill City exchange and the Wyoming State border.

## Unserved Area UA2



UA2 is just east of St. Onge in the northeast corner of Lawrence County, with a small portion in southern Butte County. It is approximately 21 square miles and is bordered by the Whitewood, Spearfish, Belle Fourche and Nisland exchanges.

## Unserved Area UA3




