SUBJECT: TC13-026 – BIANNUAL CERTIFICATION OF STUDY AREA BOUNDARIES

STAFF MEMORANDUM

In June of 2013, the Commission approved the study area boundaries (SABs) of incumbent local exchange carriers (ILECs) in South Dakota, and Staff filed those SABs with the FCC. On January 9, 2014, the FCC released an Order¹ clarifying that annual updates must be submitted by March 15 of each year, with biannual certifications required when no changes are made. In March of 2014, Staff requested the Commission delegate the authority to certify SAB changes with certain exceptions. The Commission granted Staff's request, and delegated the authority "to certify [SAB] changes with the exceptions that the Commission will certify the [SABs] biannually and if any ILEC disputes Staff's authority in this matter, it may petition the Commission for relief."²

Staff's intent was to file the most current SABs every March, while opening a docket every other January (beginning January of 2016) for the Commission to formally recertify the SABs. On March 12, 2015, the FCC released a Public Notice³ clarifying that their biannual recertification deadline will be May 26, 2015. On March 23, 2015, Staff uploaded and certified the current set of SABs to the FCC. According to FCC Staff⁴, the Commission has already met the biannual recertification deadline by filing annual updates, so the May 26 deadline is not relevant to South Dakota ILECs. However, to line up our biannual recertification with the FCC's (in odd years), Staff thought it was necessary to have the Commission certify the current SABs in 2015.

With the filing of this memorandum, Docket TC13-026 will be reopened, and all parties to the Commission's original certification will be served with this notice. Staff requests Commissioners and all parties review the current maps on the Commission's website for consideration at the May 26, 2015, Commission meeting.

Since the Commission originally approved the SABs in June of 2013, three changes have been made. A map of each change is listed below, with the red line showing the boundary as approved by the Commission in 2013.




